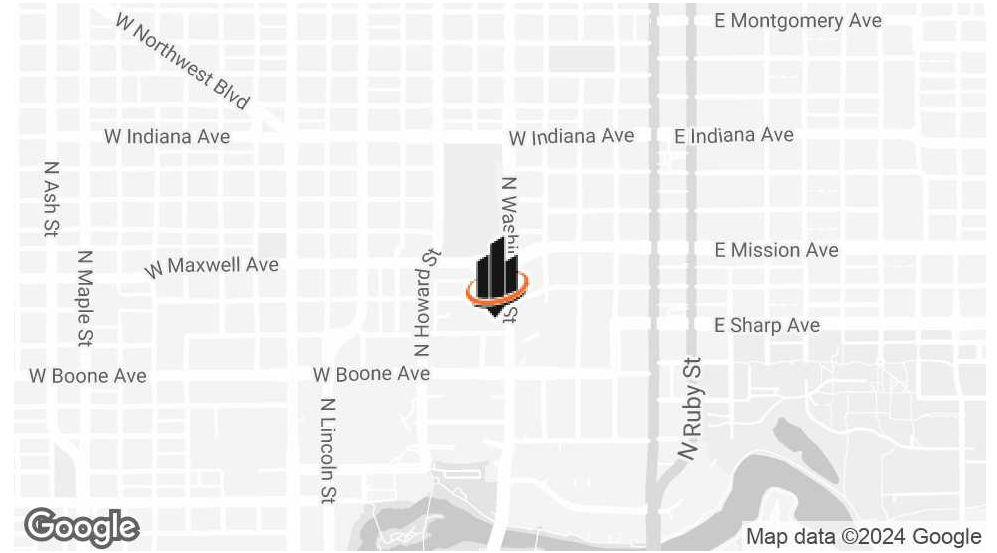

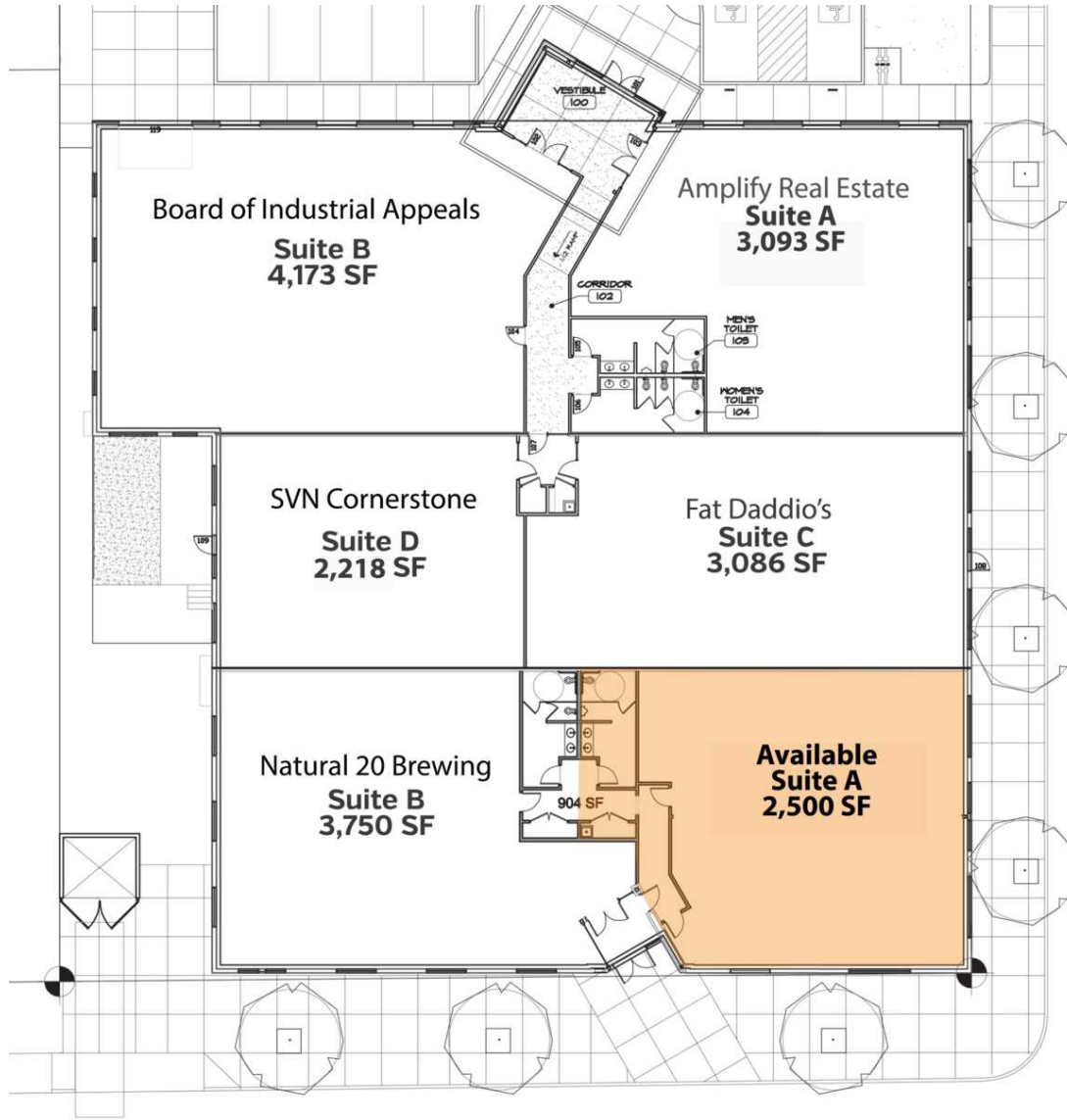

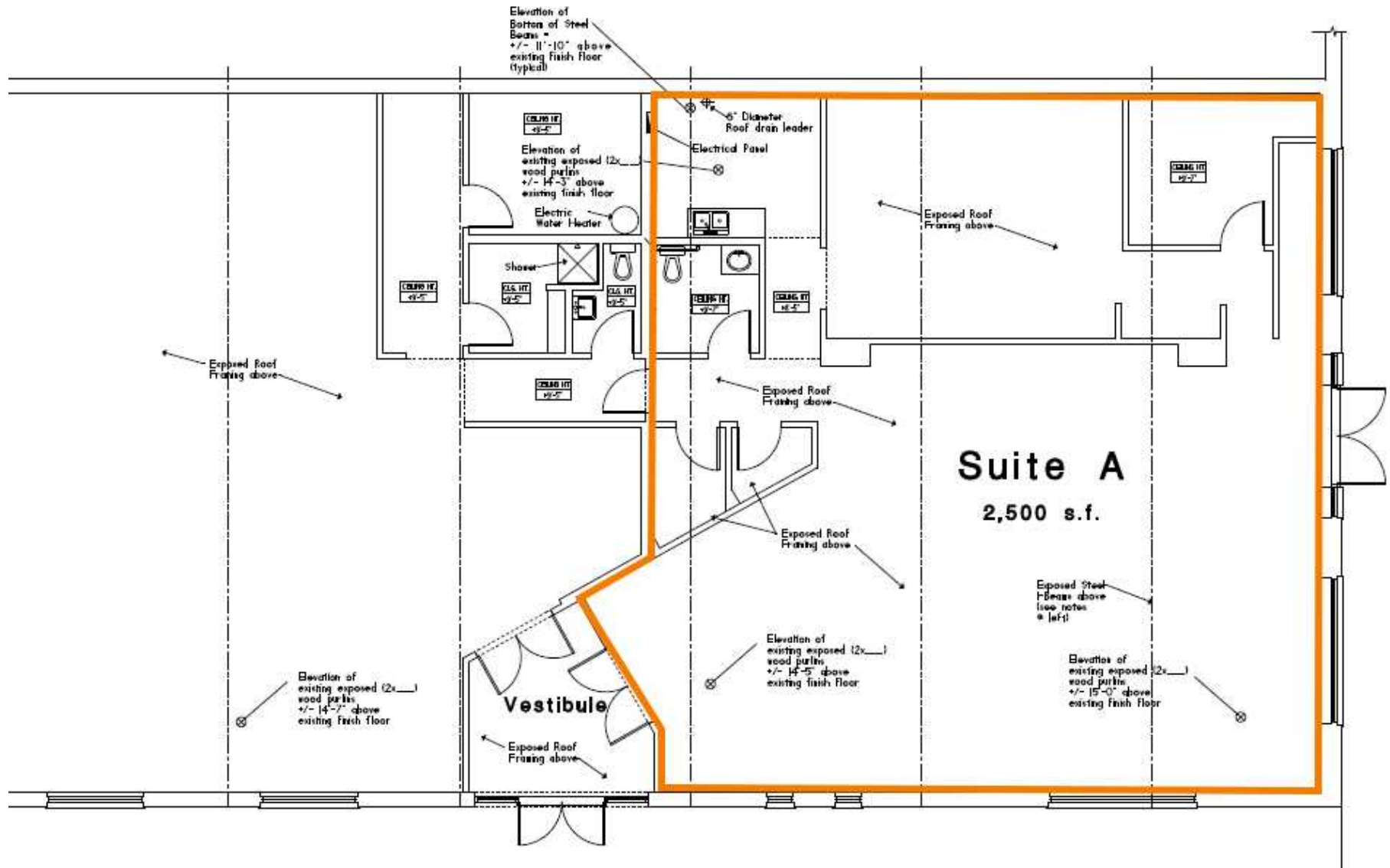

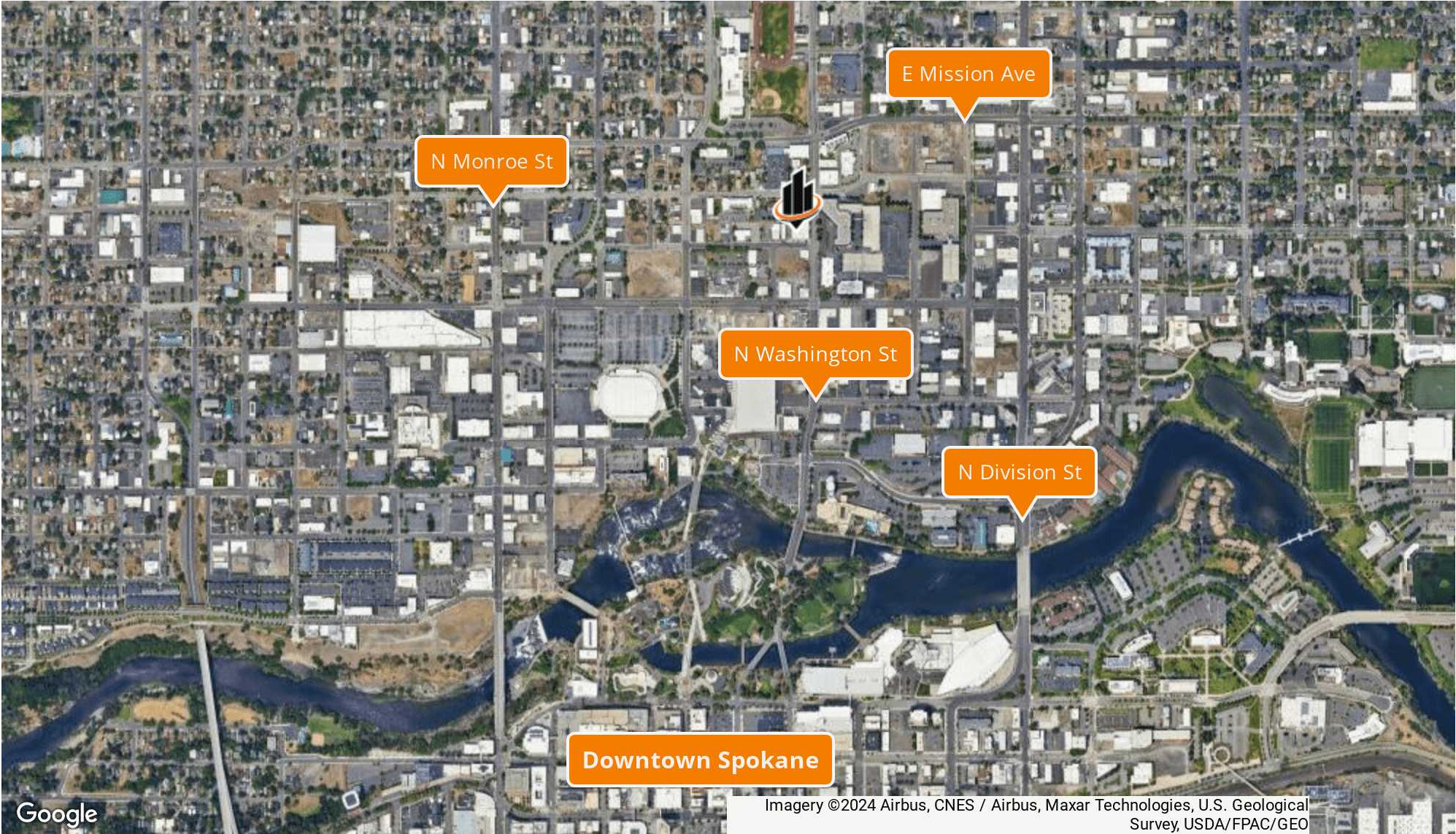
FLOOR PLAN

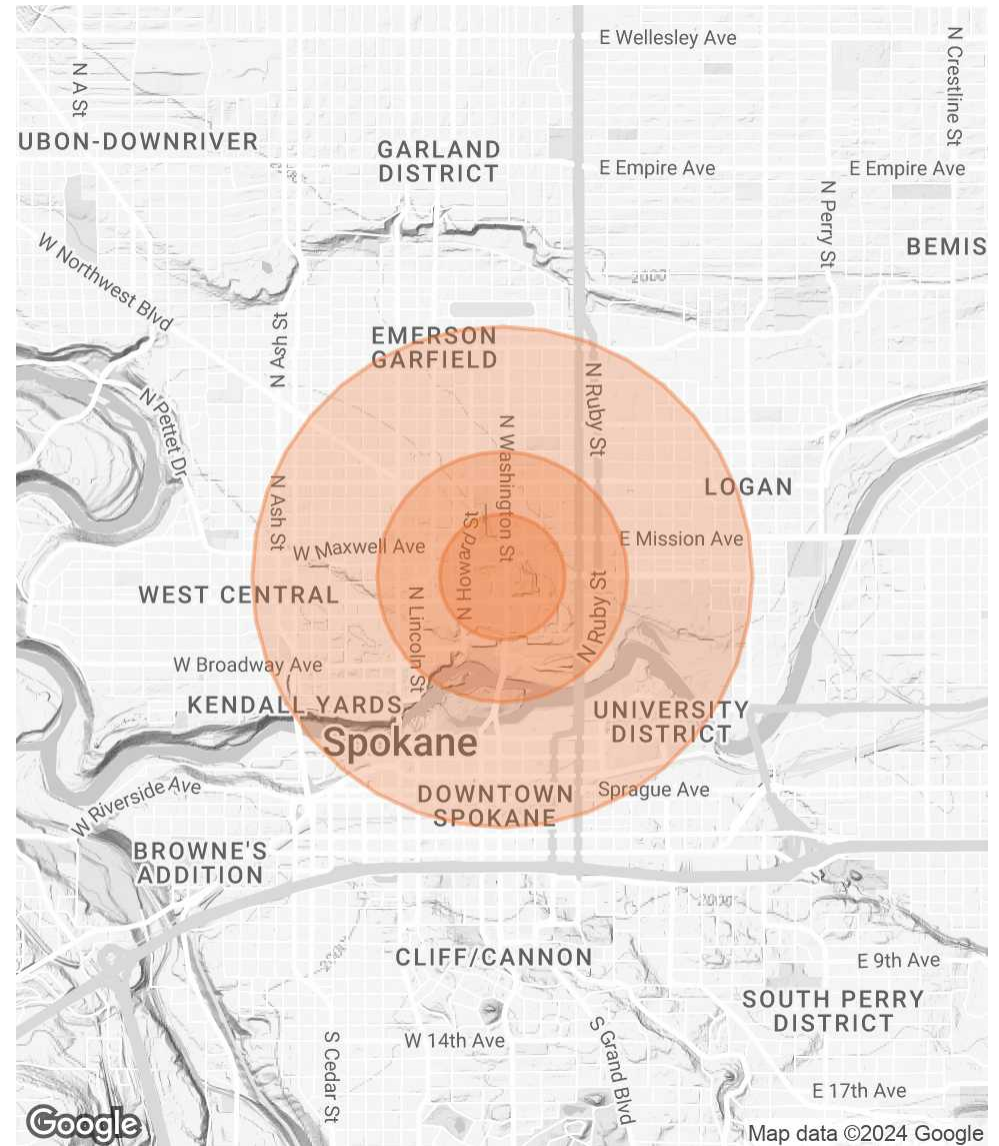
