



## SITE PLAN South Sound Center






# SOUTH SOUND CENTER HISTORY OF INNOVATION


- Bob Blume, founder of Capital Development Company, was the original developer of the South Sound Center in 1966. It opened with 450,000 SF and 53 retail tenants and was the first interior mall in Thurston County.
- In 2001, Capital Development Company continued to innovate and stay ahead of the shopping center trends and "de-malled" the majority of the interior space of South Sound Center to bring in Target.
- Today, Capital Development Company is still owned and operated by the third generation of the Blume family and excited to grow and serve the Thurston County Community throughout their real estate portfolio.
