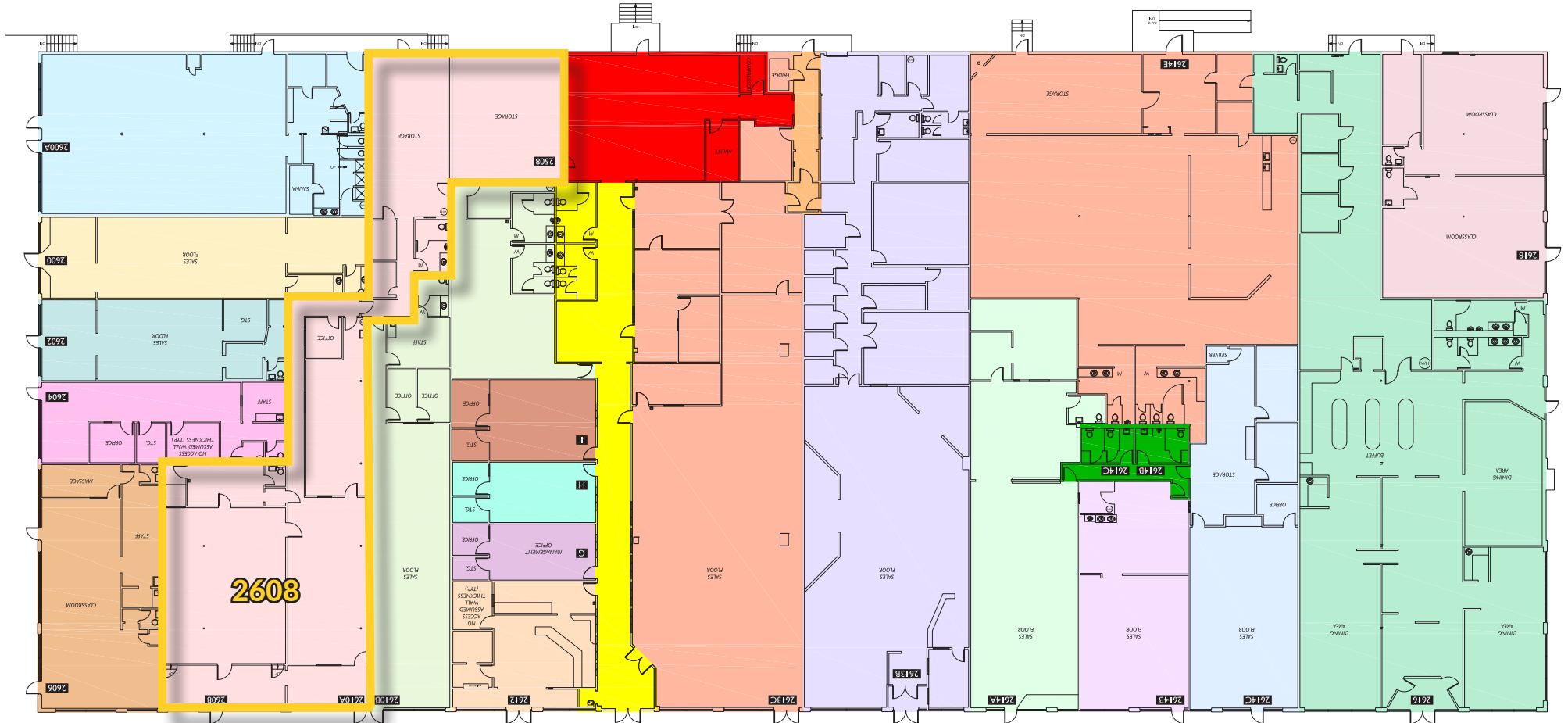

RAINIER SQUARE SHOPPING CENTER 2600 BUILDING - FLOOR PLAN

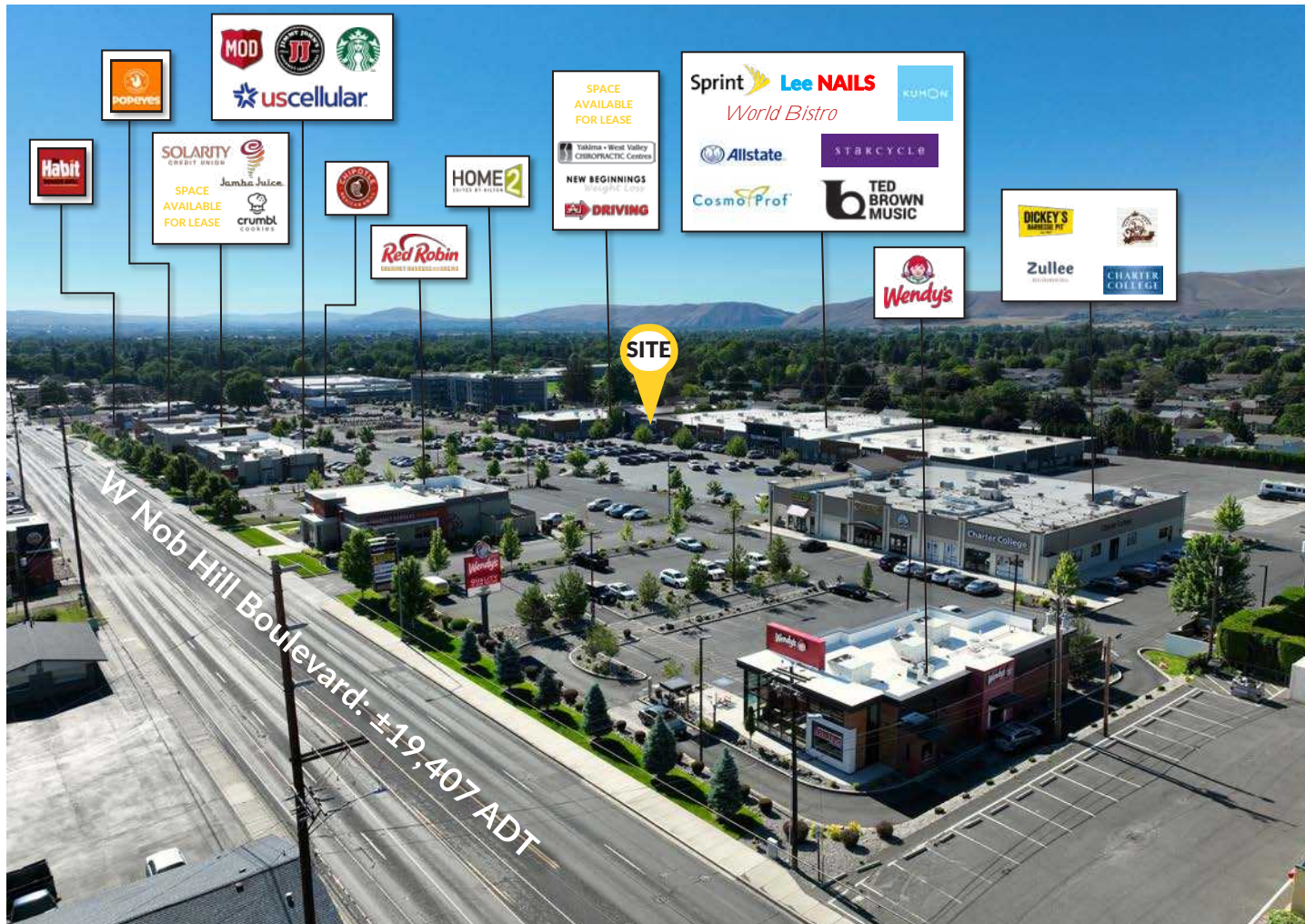

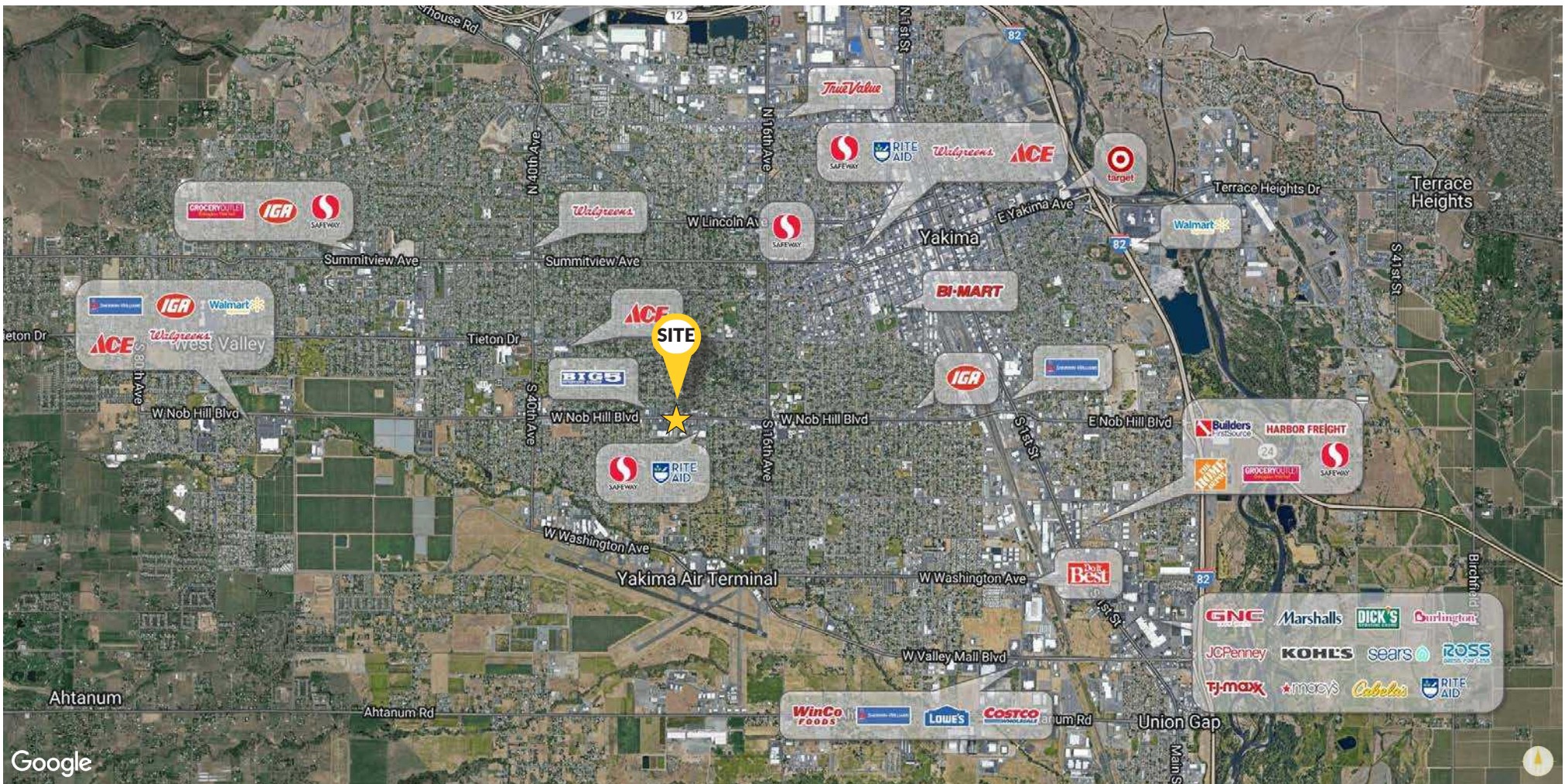
