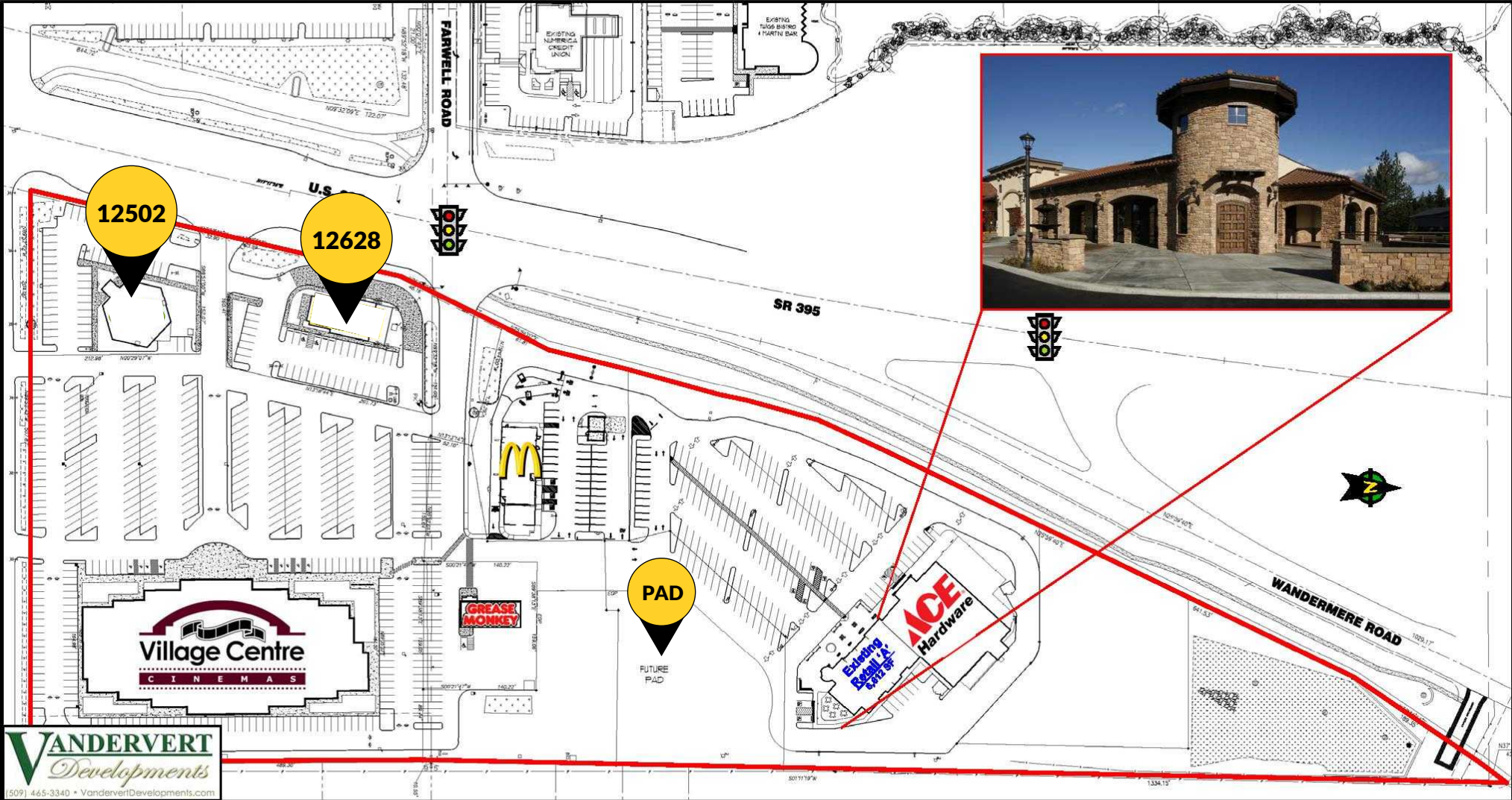

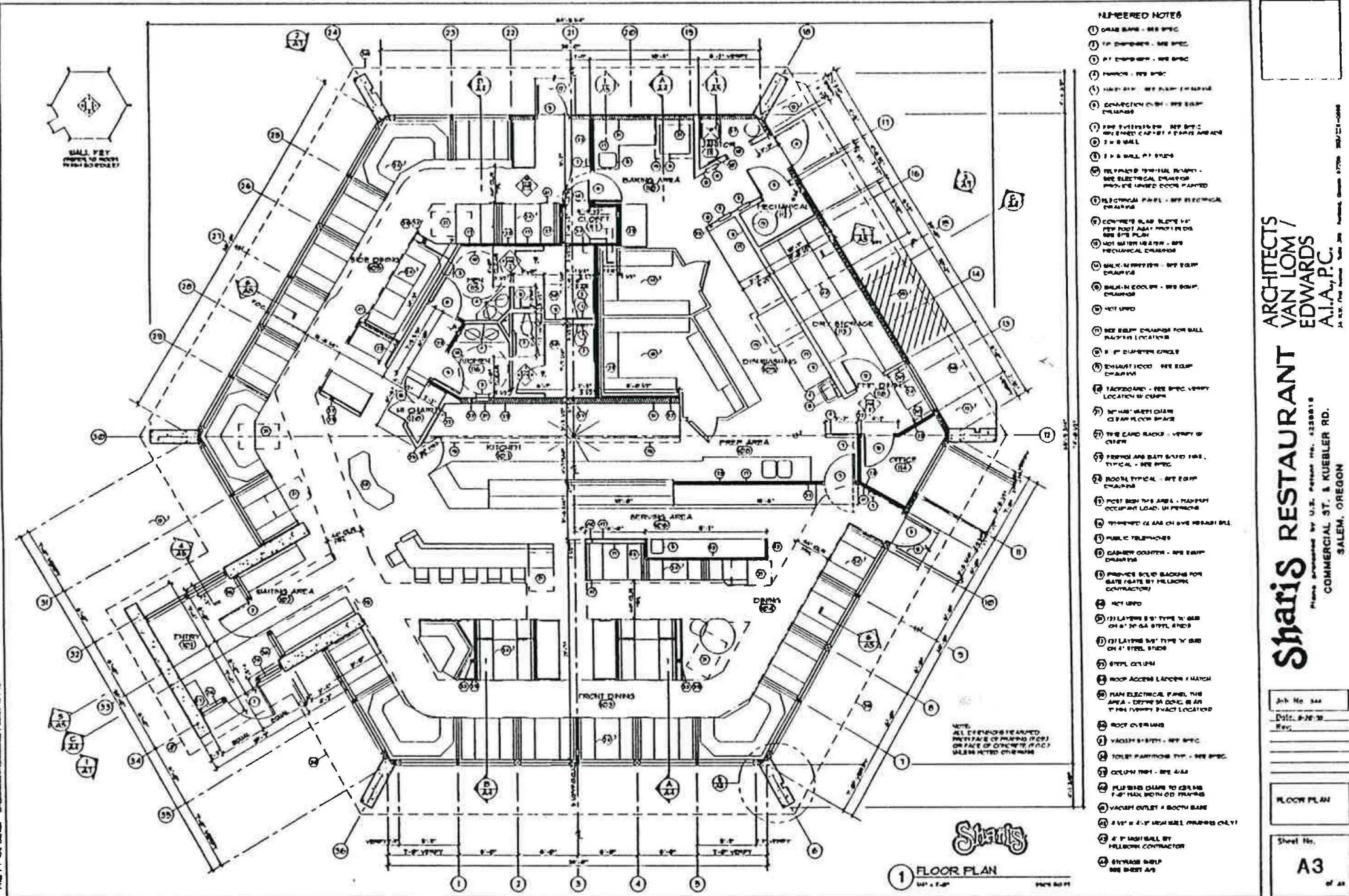

SUITE 12502 - FLOOR PLAN

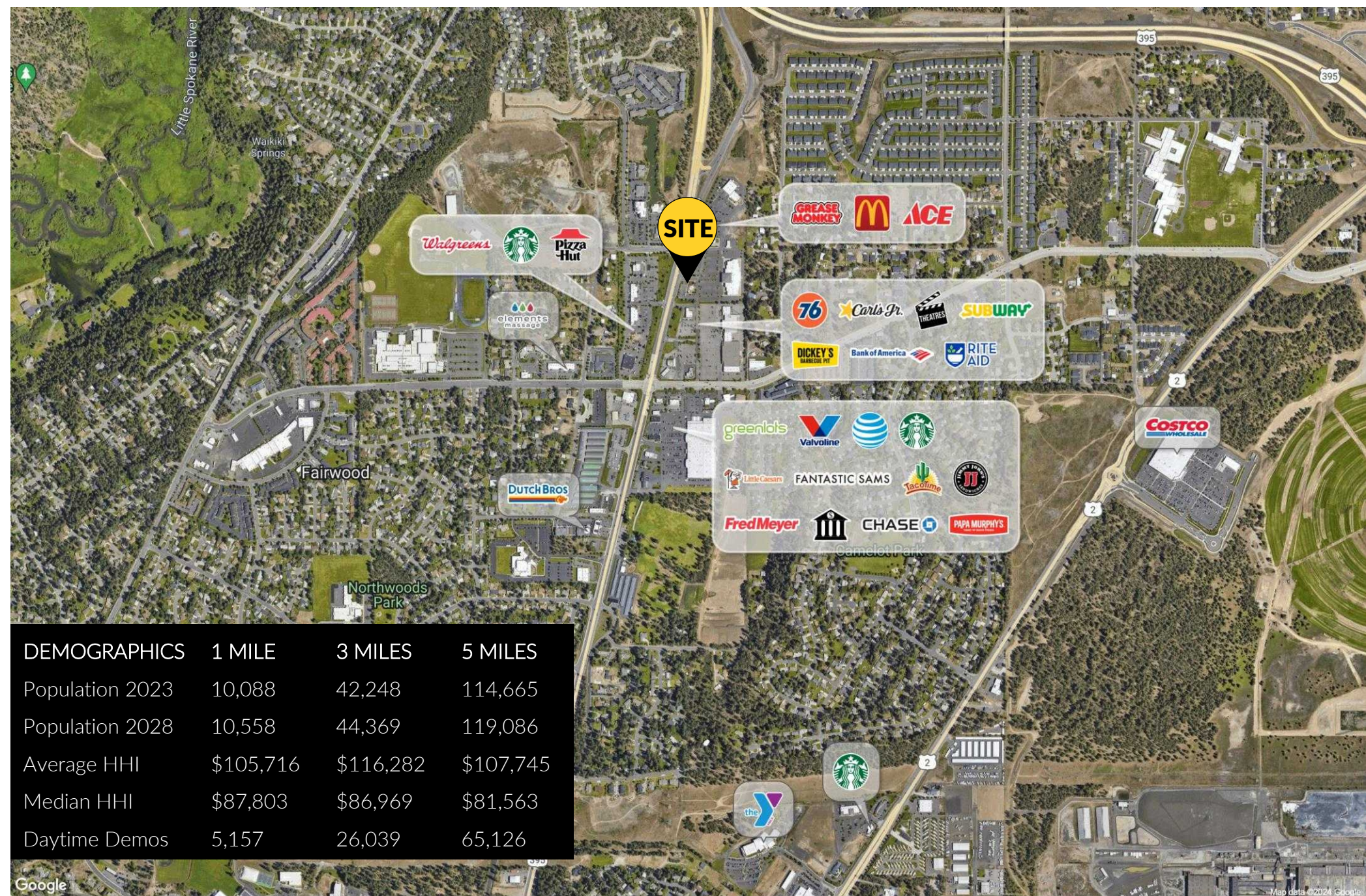
