

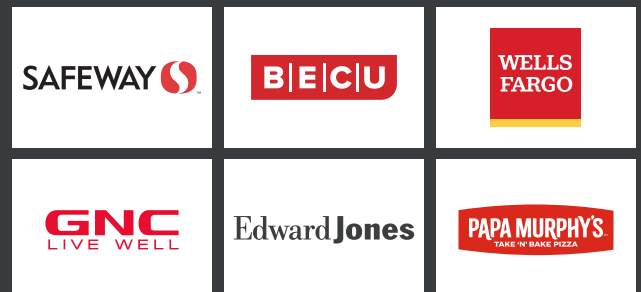

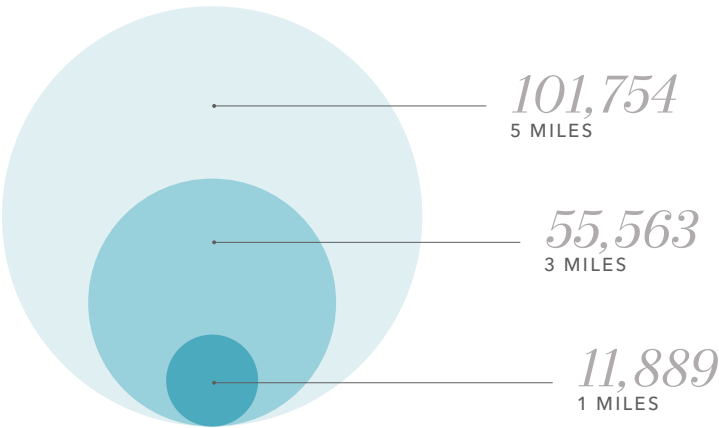

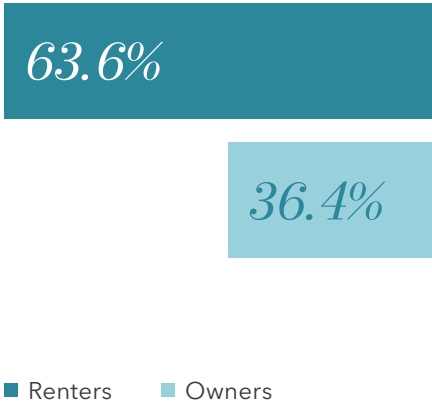
POPULATION
