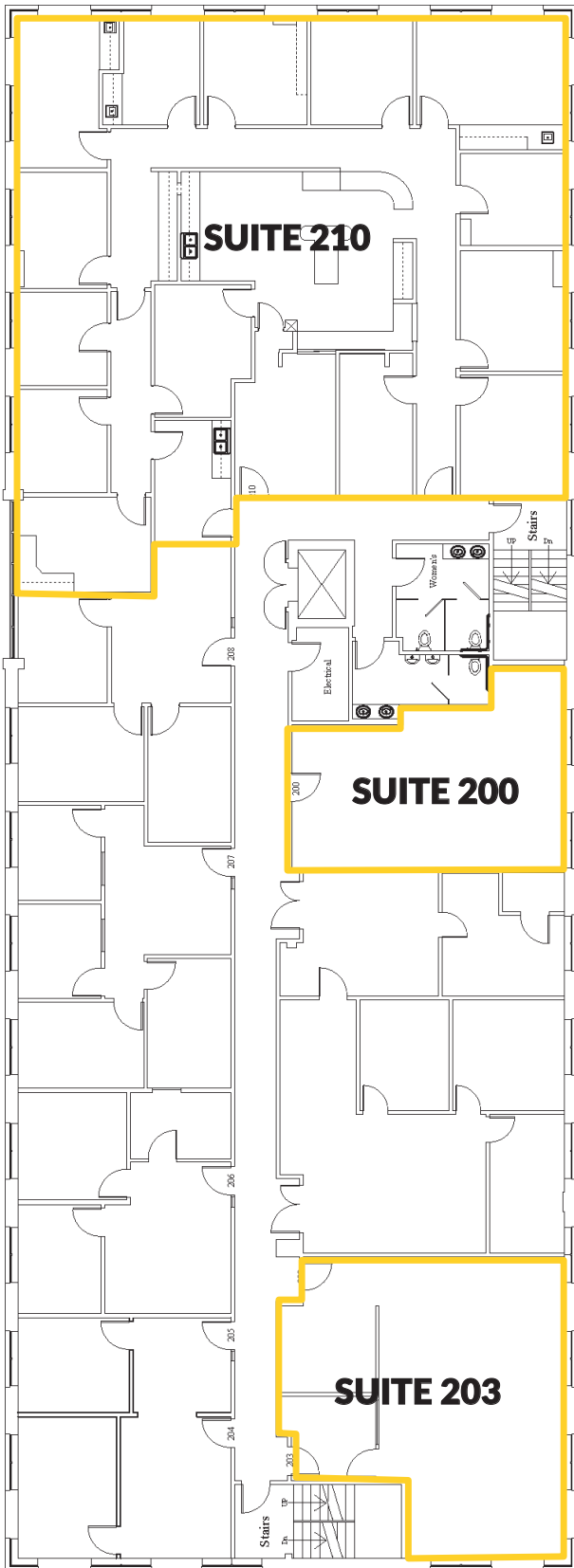

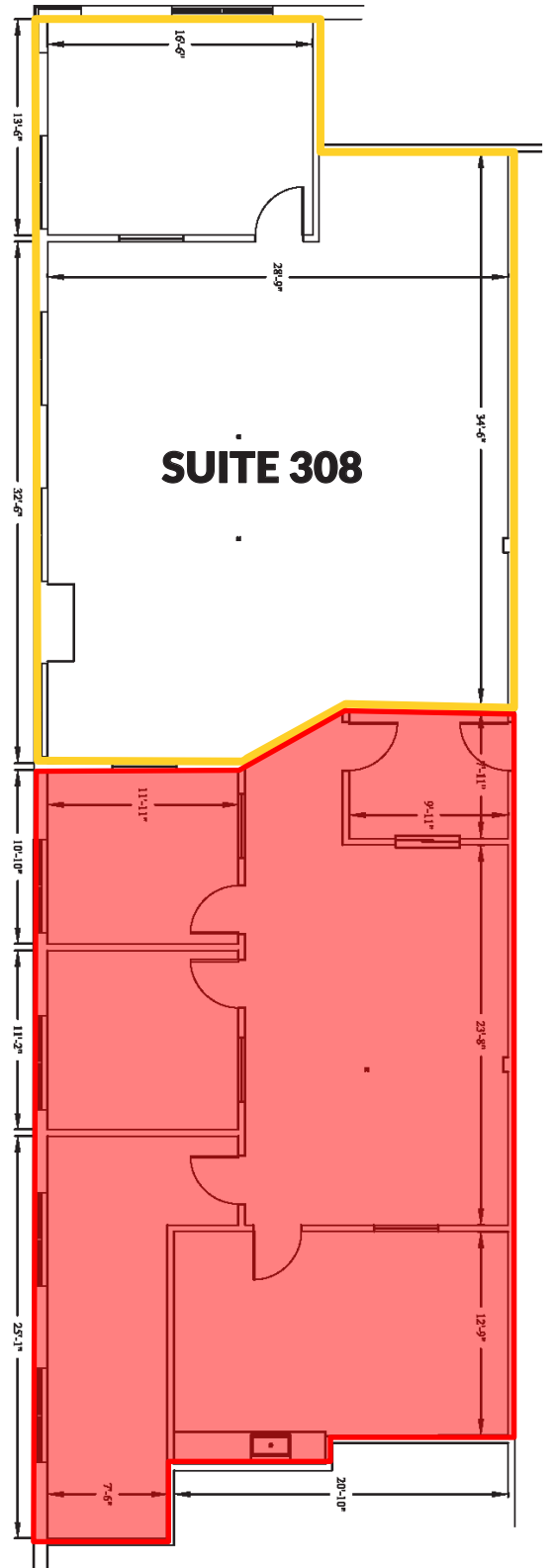

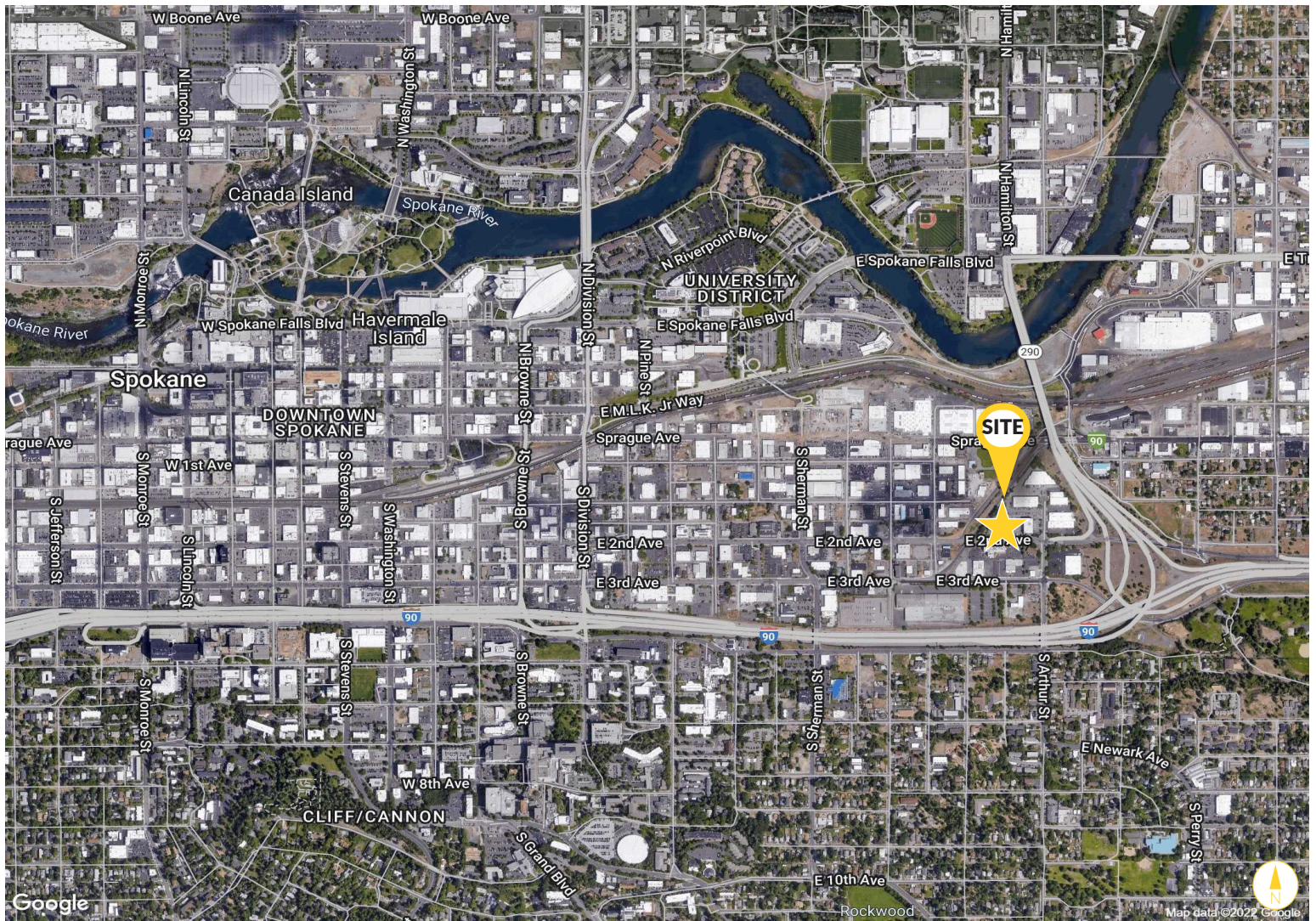
FLOOR PLANS
