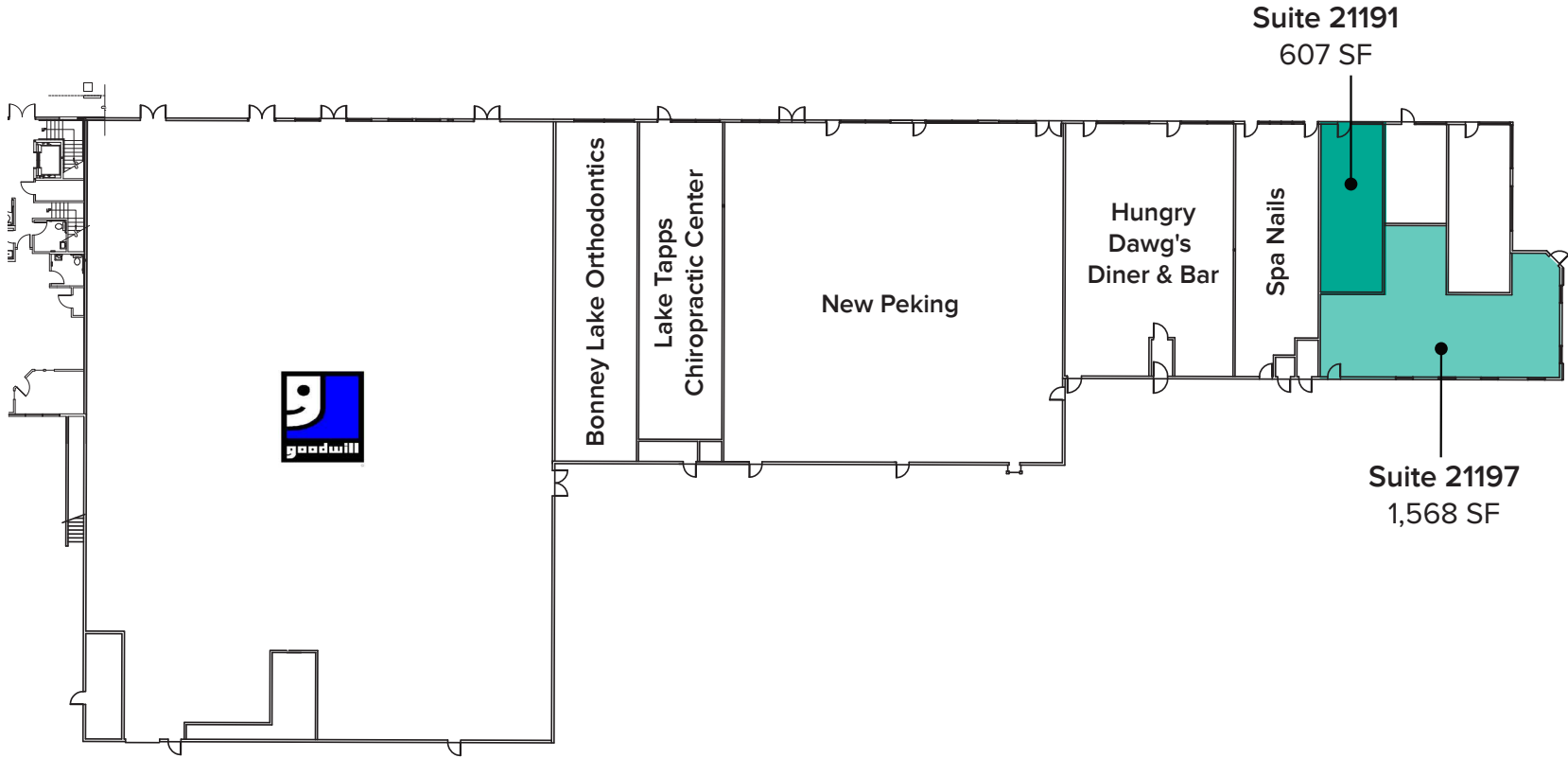

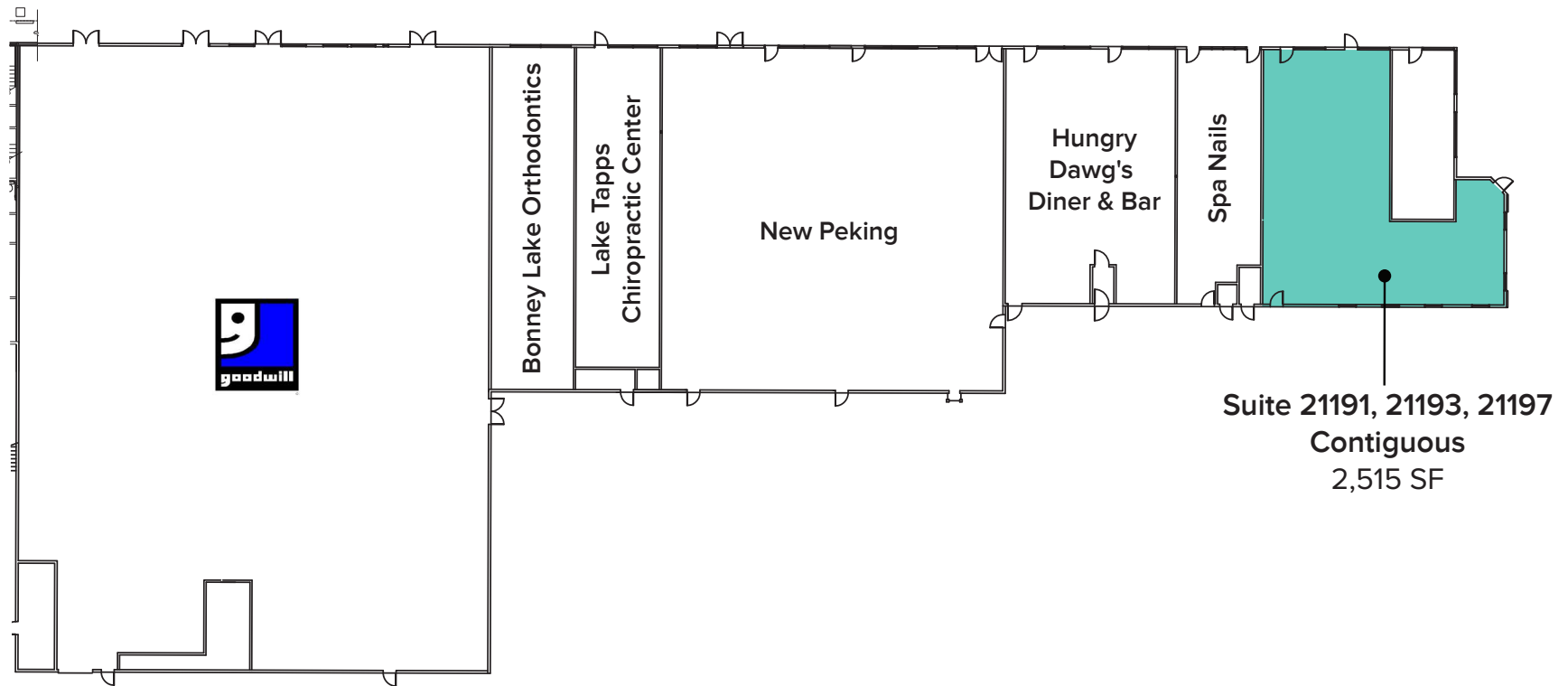

BUILDING B - SAMPLE FLOOR PLAN

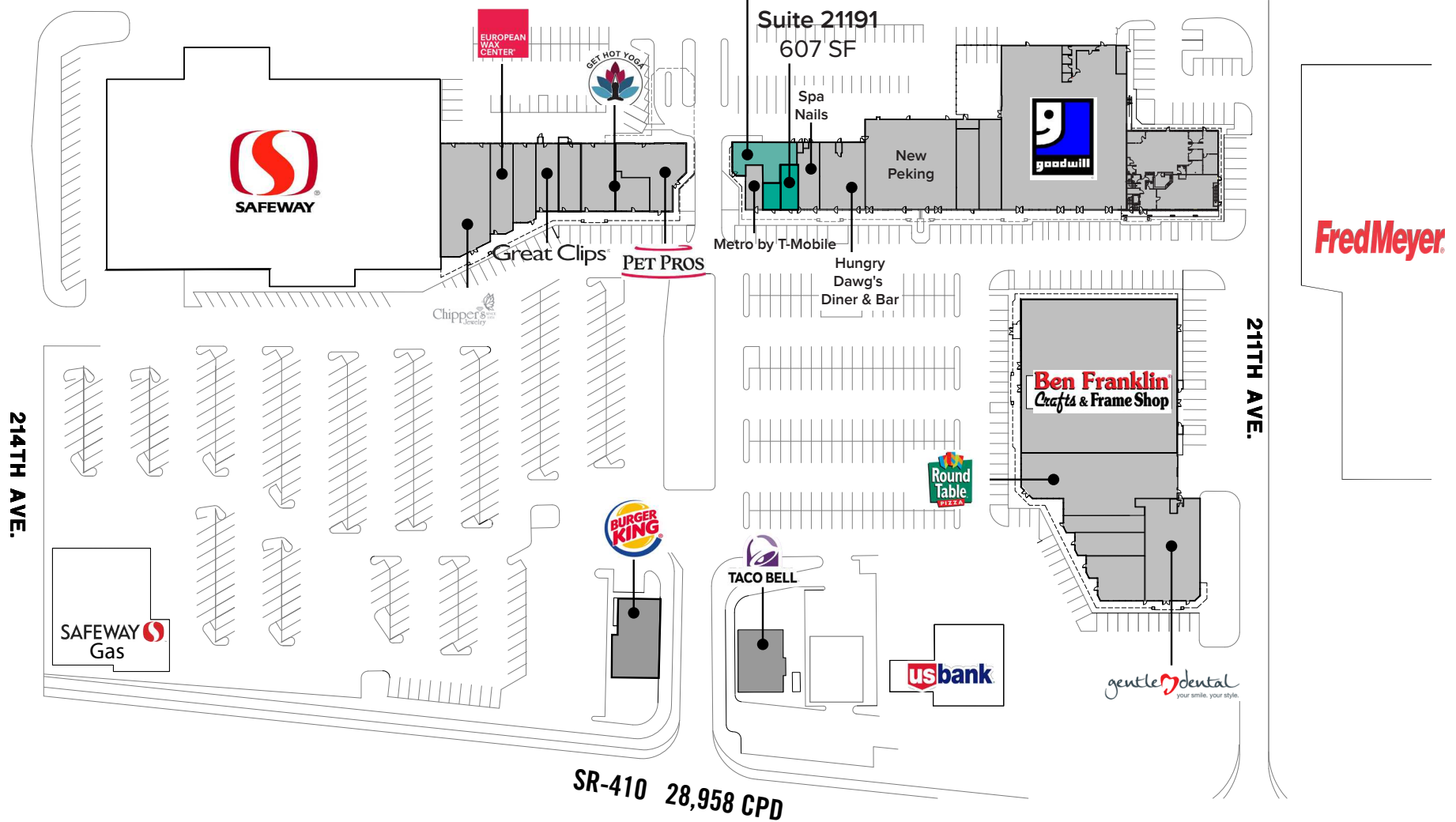
