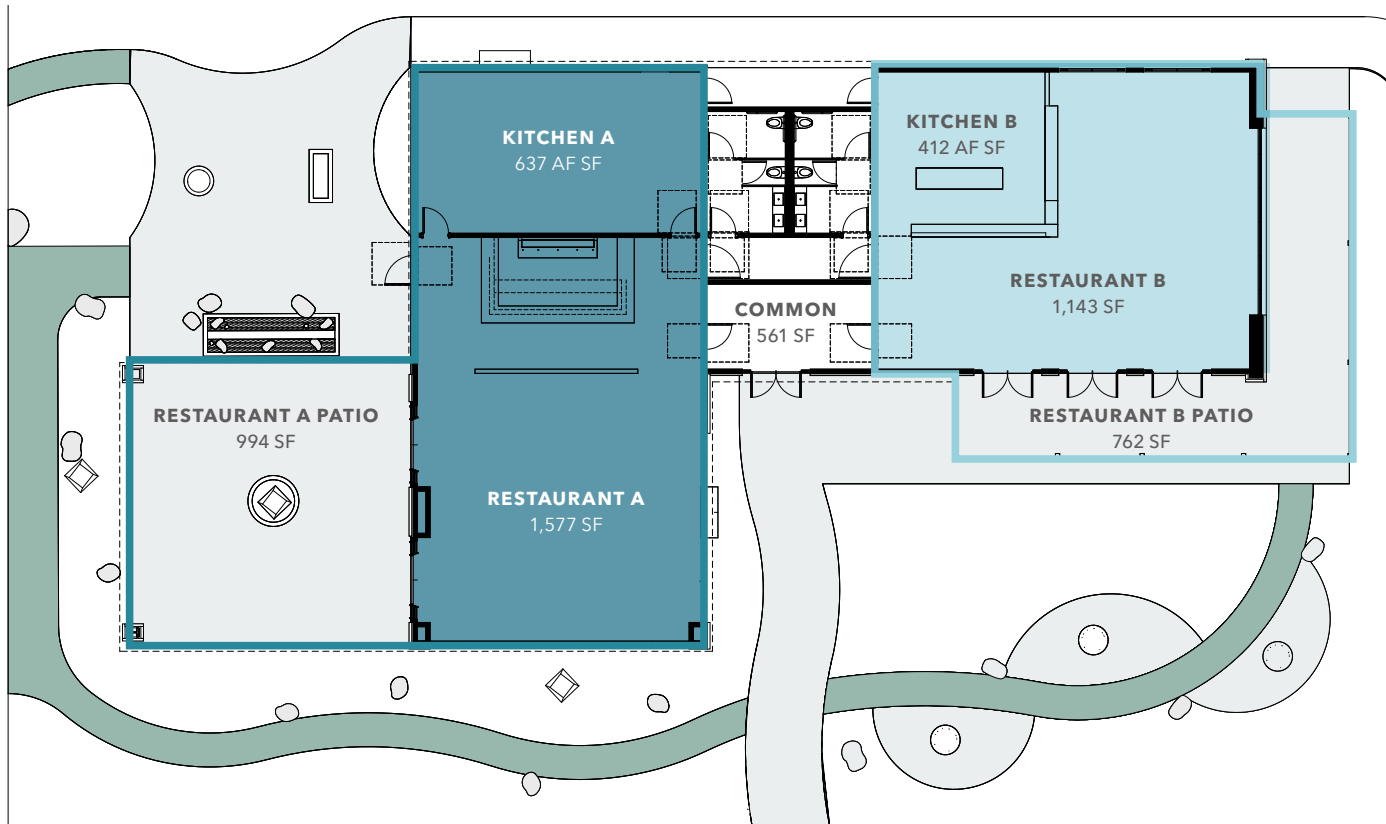
Dramatic gardens and breathtaking scenery surround the grounds, setting the stage for a truly memorable destination.

MARKET INFORMATION:

Lake Chelan attracts over 2 million visitors annually, contributing over \$417 million to the local economy and supporting over 5,000 jobs.

Tourism is a major industry in the area, second only to agriculture. The city of Chelan itself experiences a population surge from around 4,000 to 25,000 during the summer months due to the influx of tourists.

Lake Chelan hosts a variety of annual events, including the Lake Chelan Wine and Jazz Festival, Manson Hydrofest, and the Lake Chelan Swim. In the

summer, there's the Fourth of July Fireworks Display, Lake Chelan Pro Rodeo, and Lake Chelan Poker Run. September brings the Manson Hydrofest and the Lake Chelan Swim. Fall is marked by the Lake Chelan Wine Harvest, Haunted Manson, and Brews on the Bridge. Winter includes events like Winterfest, the Village of Lights and Small Town Holidays.



SITE INFORMATION:

Bellissimo is a one of a kind development coming to Chelan. Offering year round customers, Bellissimo will be a 400+ unit, Tuscan inspired development that will comprise of high end multifamily units with first occupancy planned for Summer 2027.

The development also features a great lawn, dog park, pickle ball courts and an athletic center with pool. The adjacent Walmart sees over 1.4 million visits per year and Chelan Health employs over 200 medical and administrative workers.

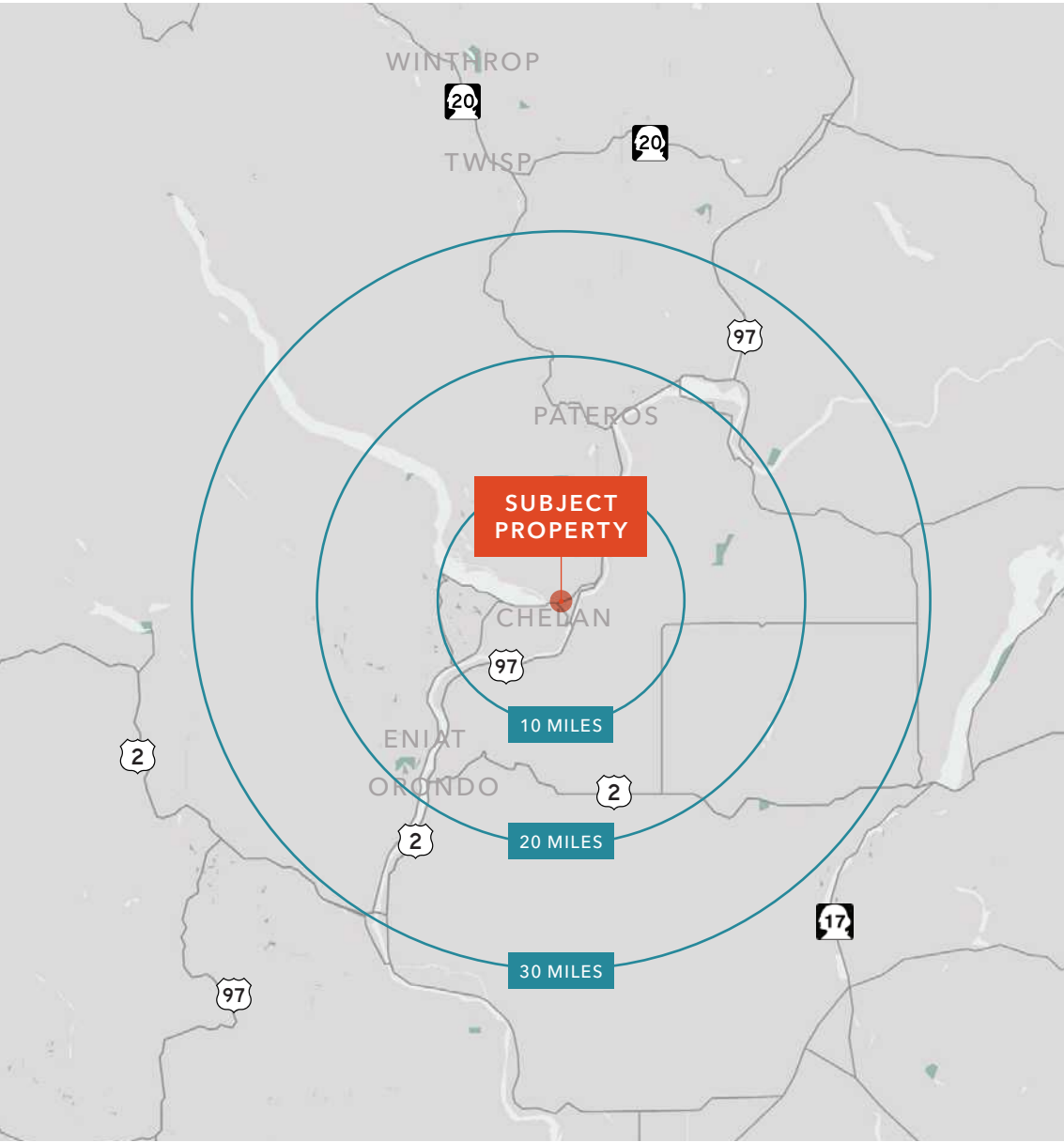
