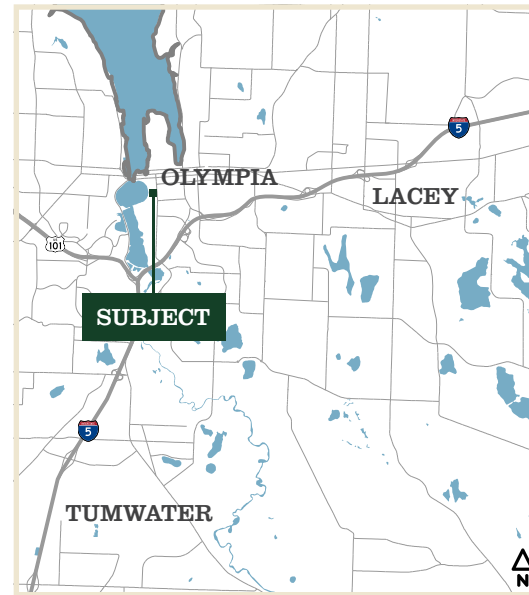
Amenities include an elevator and secure parking, serving a diverse tenant base that includes architectural and professional firms. This property is located in a very walkable area with a Walk Score of 82.

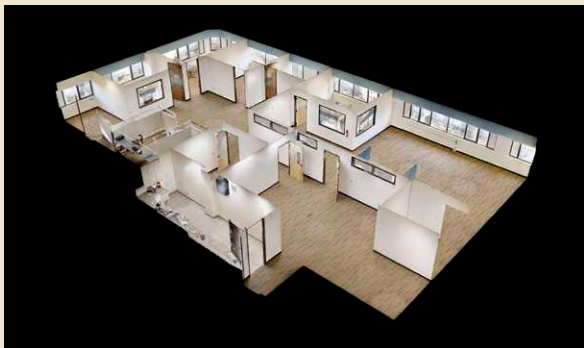
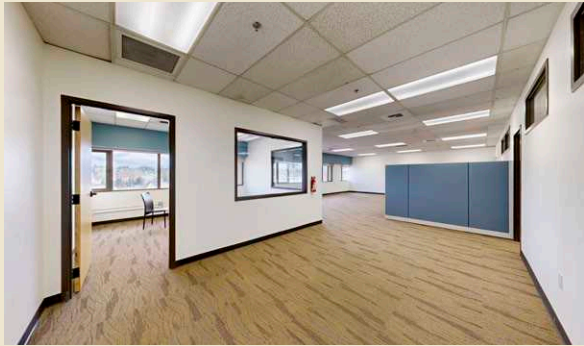

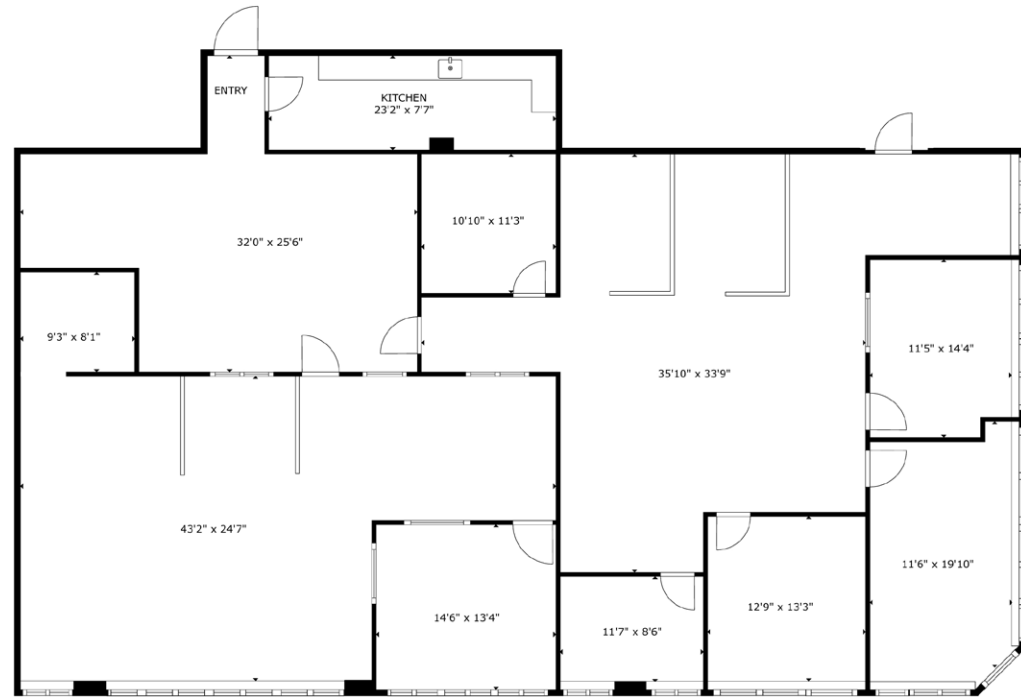
