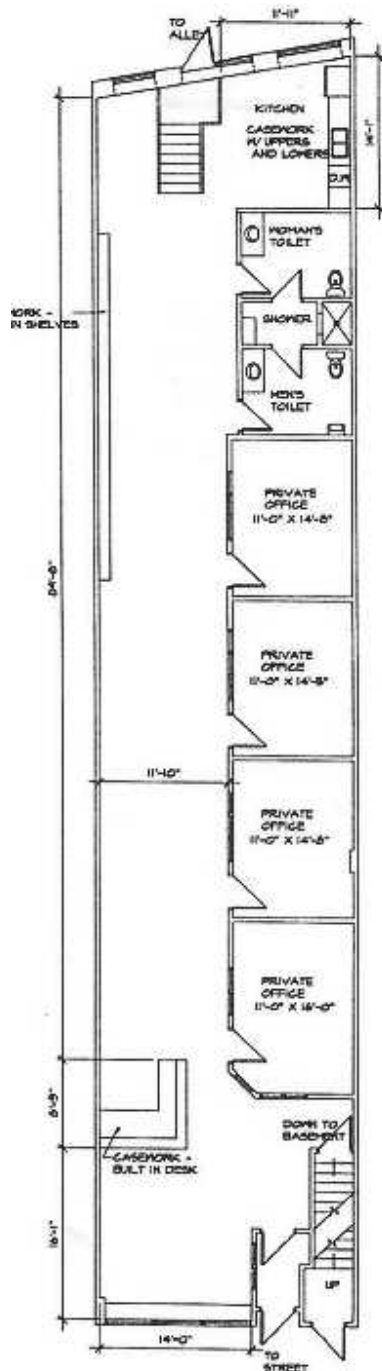

FLOOR PLANS

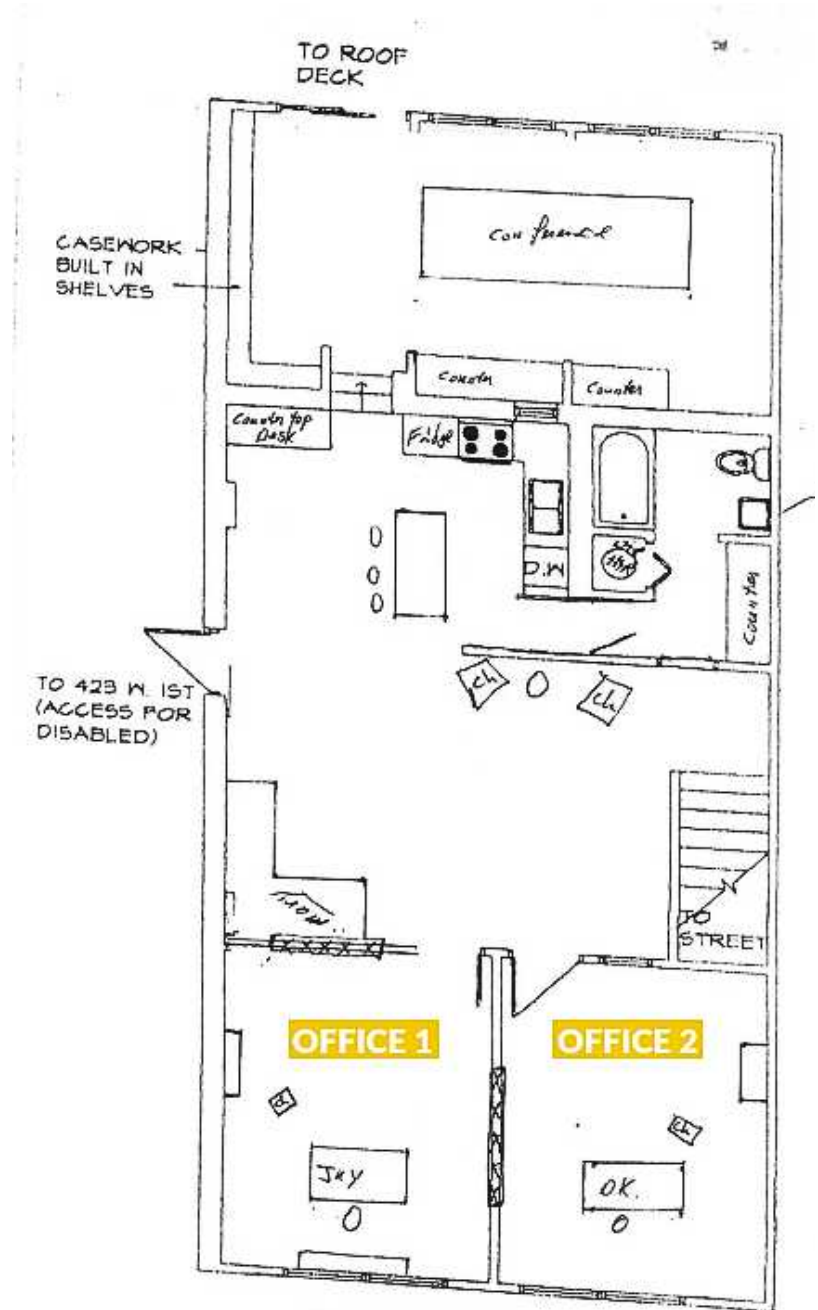
MAIN FLOOR

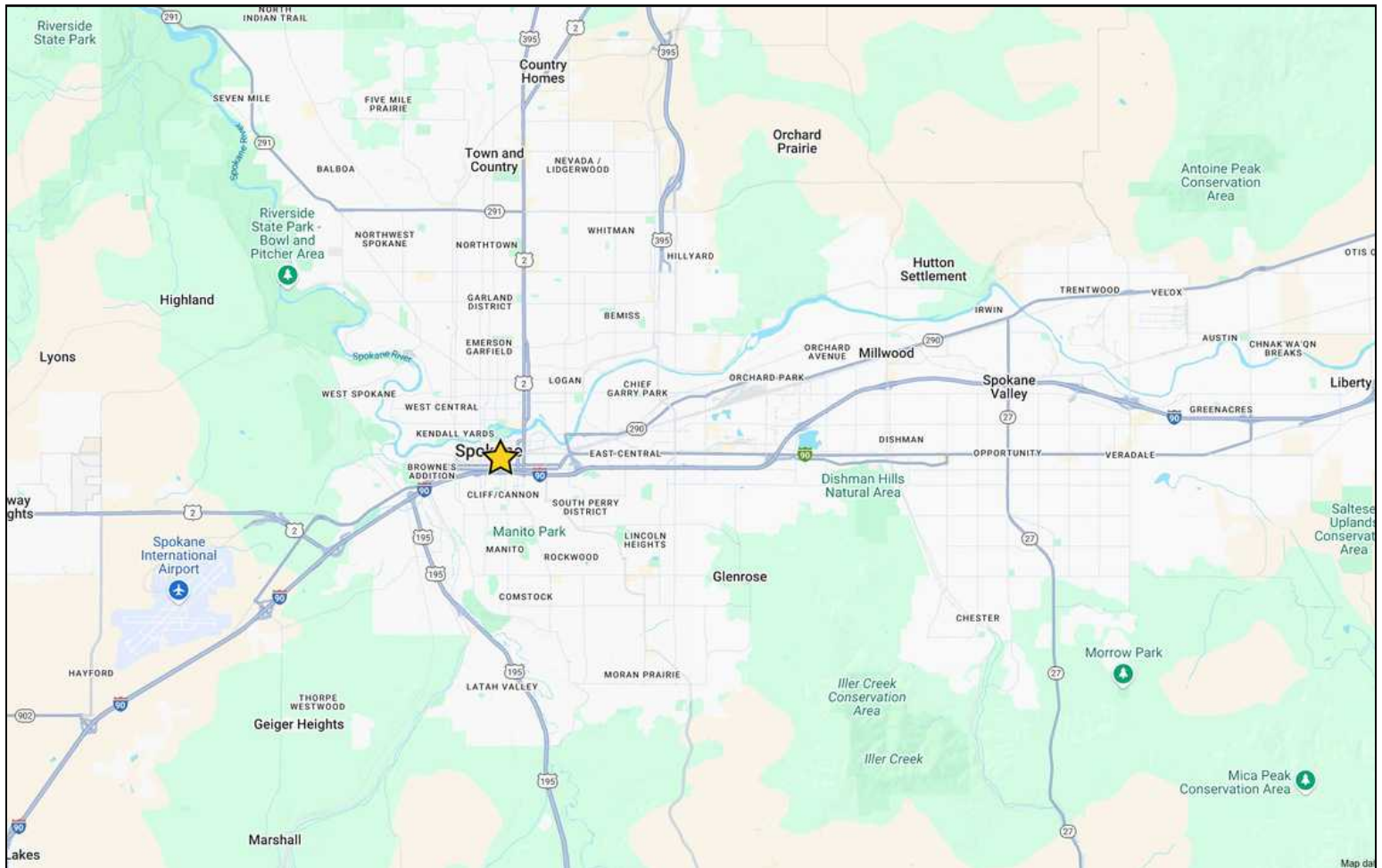
