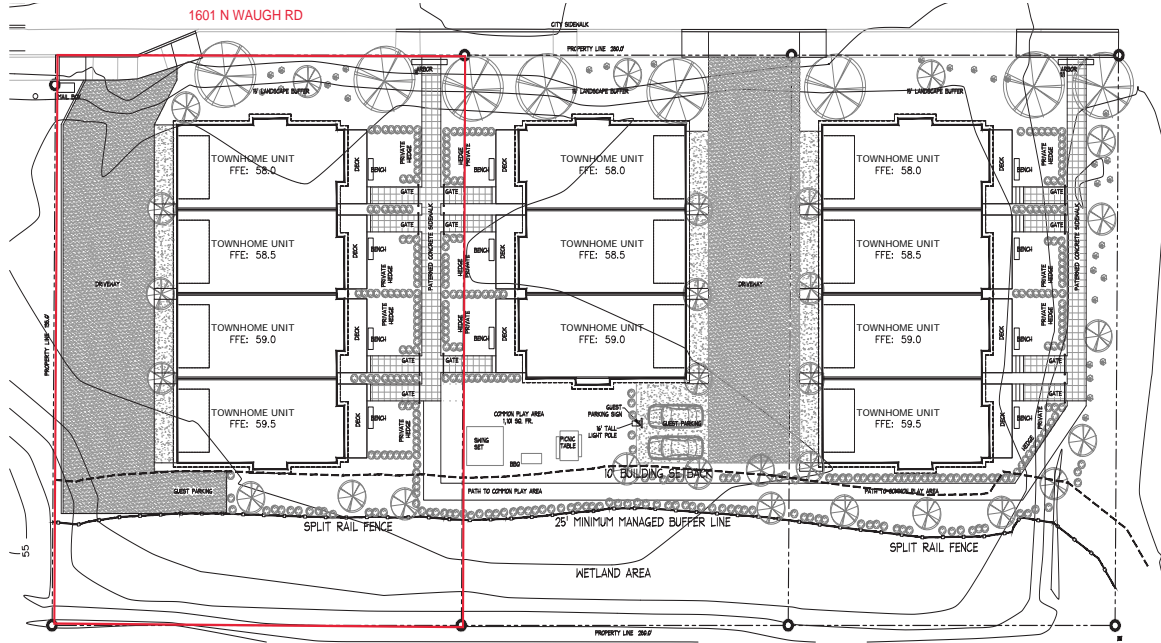

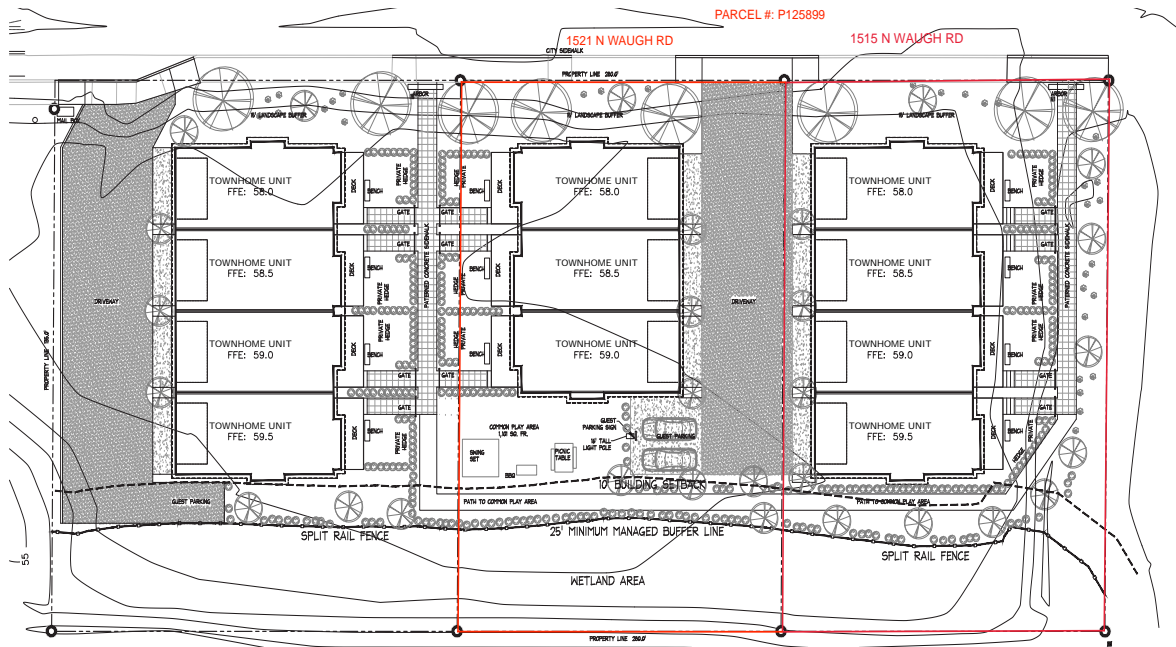

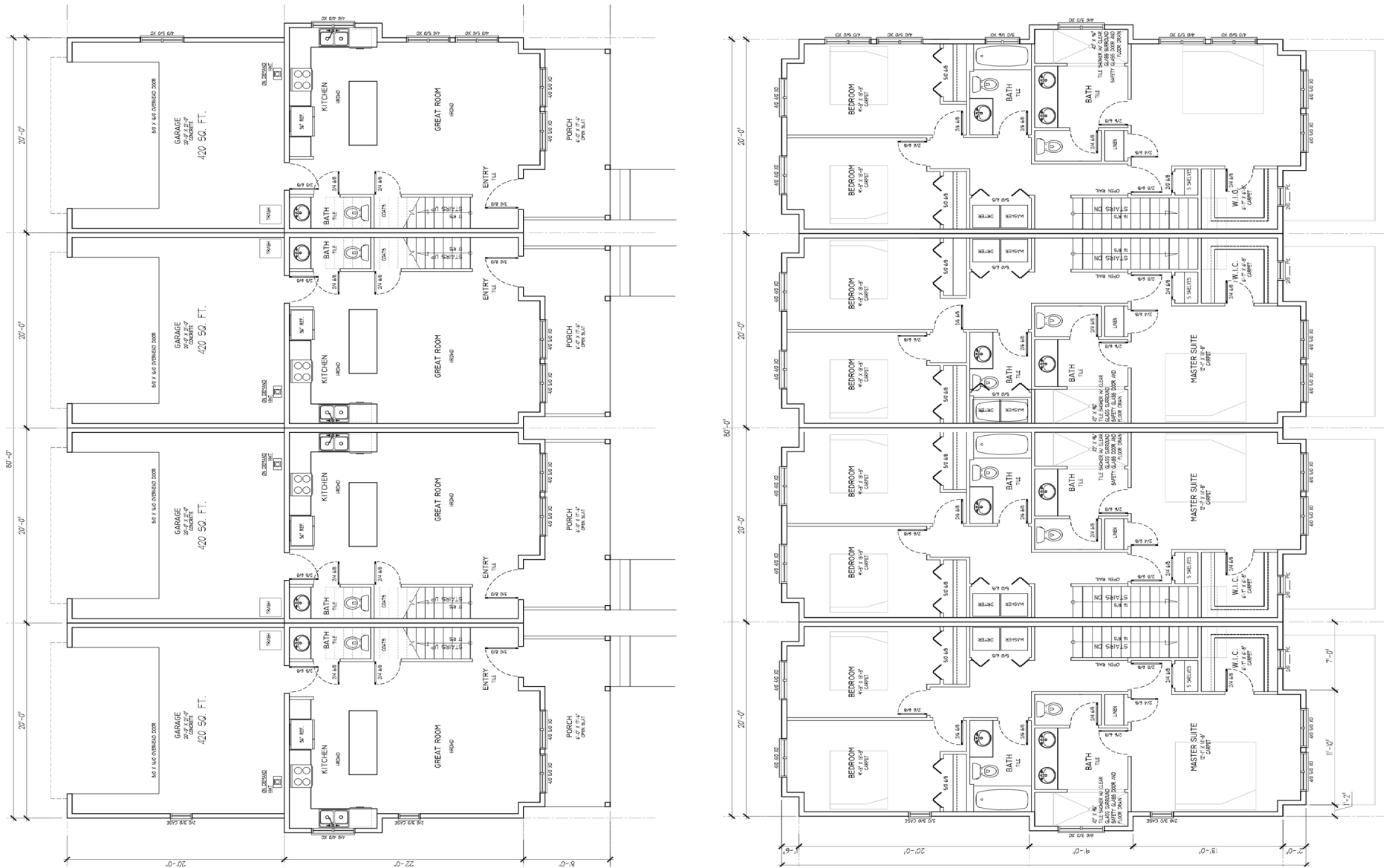

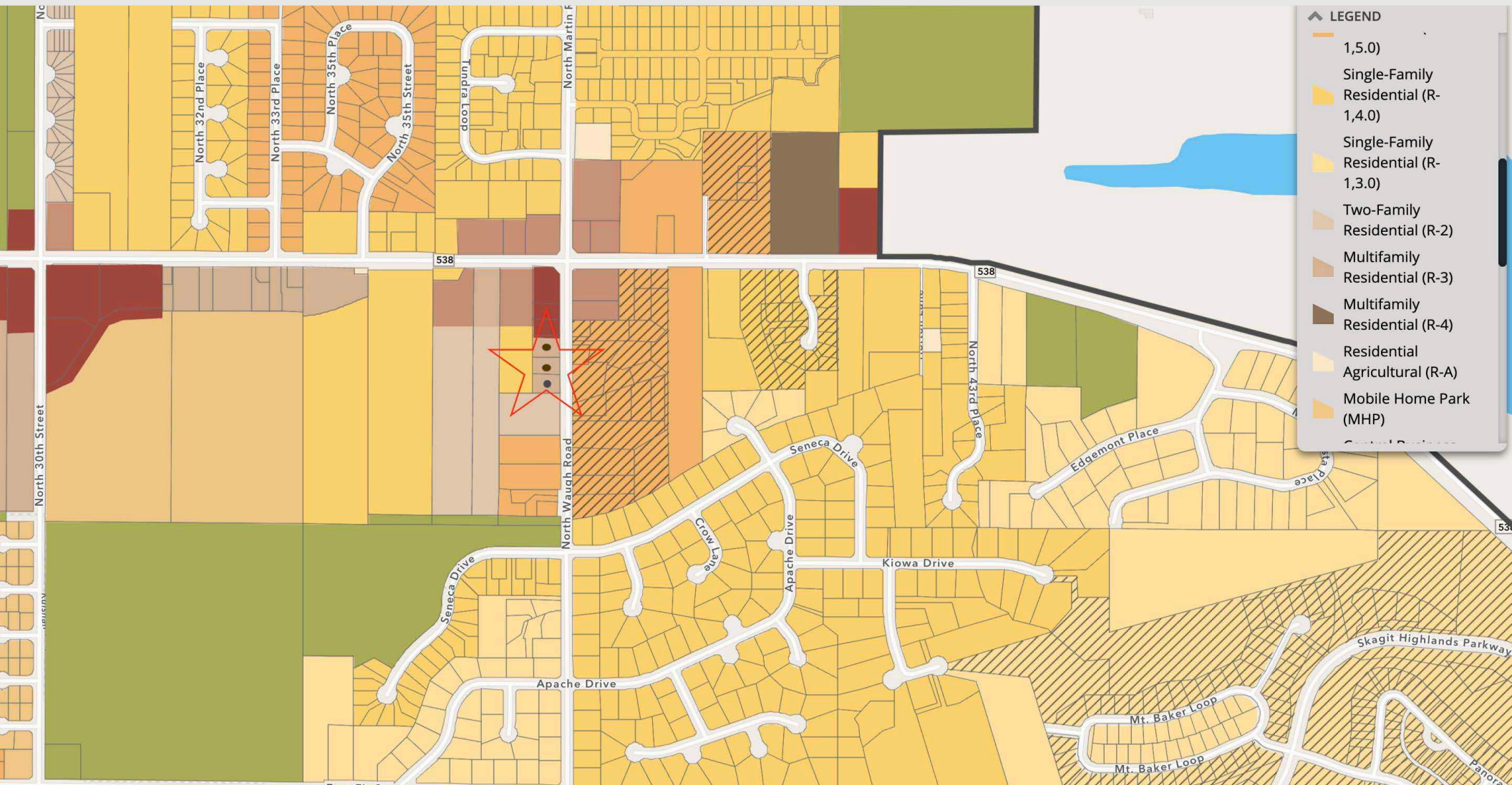

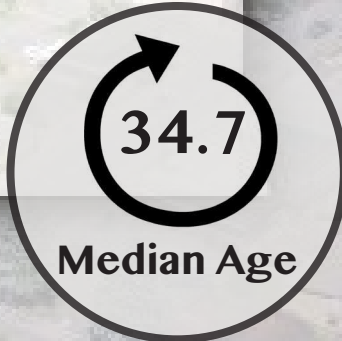
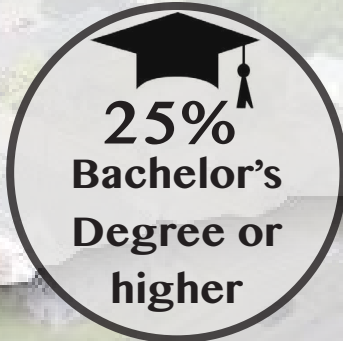


DEMOGRAPHICS
