








Cushman & Wakefield Capital Markets is pleased to present an exclusive opportunity to acquire Villa Luisa, a vintage mixed-use community situated in the heart of Ballard, Seattle. This charming property comprises 16 apartment units, offering a mix of studios, one-bedroom, and two-bedroom units. Villa Luisa also hosts four longstanding retail tenants with storefronts along 15th Avenue Northwest. These tenants include Nolita Italian bistro, The Wax Bar, a mini-mart, and an art studio, all of whom have signed leases through 2026.

Built in 1927, Villa Luisa still exudes its classic old-world charm. Prospective buyers can take advantage of the current loss-to-lease rate of 8%. Furthermore, with a renovation strategy in place, modernized units could command an additional \$300+ in rents. There's even more upside potential with the opportunity to develop the old garage and storage space into either townhomes or apartment units. The available space along the alley can support up to 9,000 square feet of additional structure.

Ballard is widely renowned as one of the most walkable and amenity-rich neighborhoods in Seattle. Villa Luisa's location within Ballard is superb, providing easy access to dining, beverages, and amenities on Ballard Avenue, NW Market Street, and NW 65th Street. The Rapid Ride D Line stops directly outside the community, offering express bus service to Queen Anne, South Lake Union, and Downtown Seattle.

Core Ballard Location

Exceptional location at the corner of 15th Avenue NW and NW 60th Street, within walking distance of restaurants, bars, and shopping on Ballard Ave and NW Market Street. The D Line Rapid Transit stops on the corner and provides express service to Queen Anne, South Lake Union, and Downtown Seattle. Walk Score of 96 and a Bike Score of 92.




Immense Upside

Buyers have the immediate opportunity to increase income, as current rents are well below market comparables, and only 50% of utilities are currently being recovered. Additionally, there is further potential for increased income by rehabbing and modernizing units to raise rents even more.



Development Opportunity

The existing garages can be torn down, and the available land can support between 2-3 townhomes or roughly 9,000 square feet of apartment units. A site plan has been developed in collaboration with Workshop AD, and an initial intake meeting with the city has already taken place, with the city actively encouraging development.


