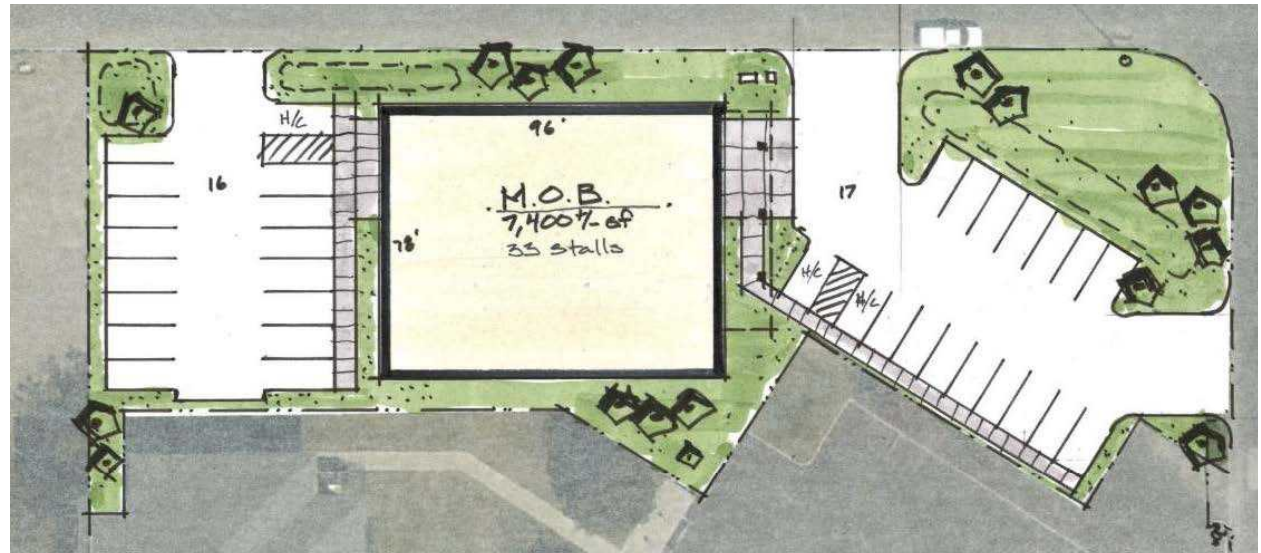

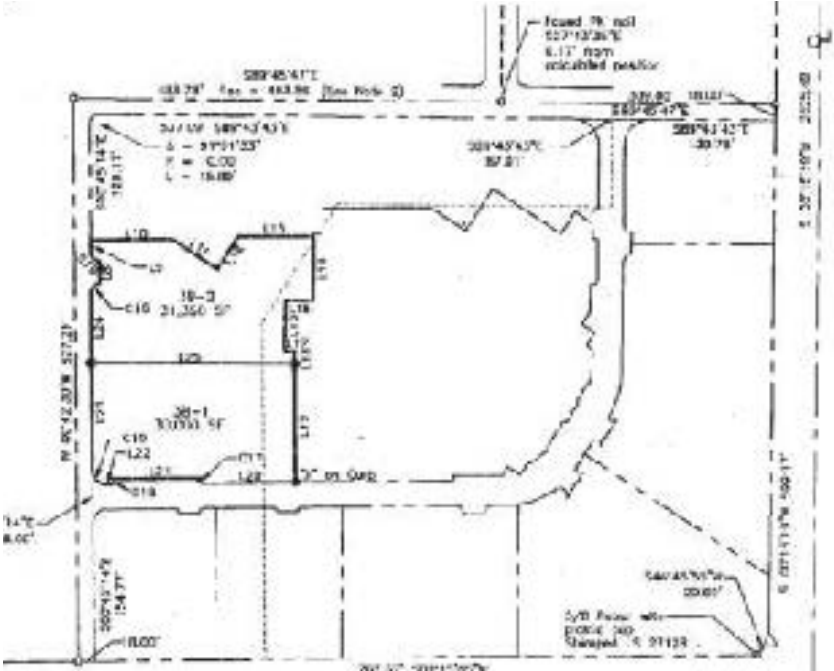

Proposed Building & Site plan



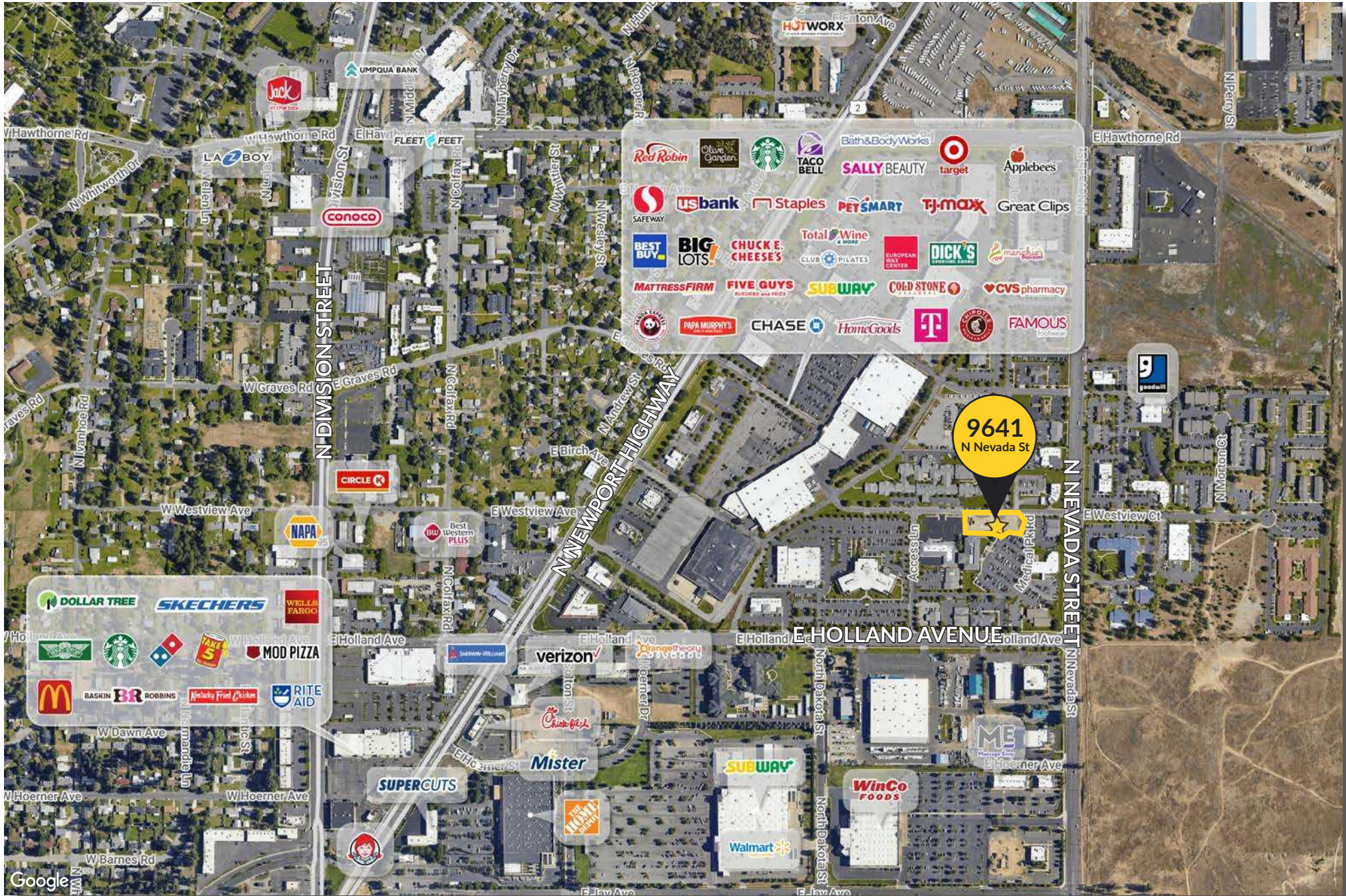
