

# SON MIXED-USE BUILDING CONSTRUCTION PERMIT: 6598837-CN



The project is located on N 45th Street in the commercial core of the Wallingford Residential Urban Village in a NC2P-55 zone. The proposal consists of a 4-story Mixed Use building with one retail or restaurant suite at the Ground Floor with  $\sim 1,500$  SF gross floor area. Twelve 1–Bedroom apartments in two different sizes are proposed for the three upper stories with  $\sim 6,800$  SF gross floor area and a total of  $\sim 9,200$  SF of building gross floor area. Since the site is located in a Residential Urban Village and has good frequent transit access, no parking for cars will be required or provided. Covered bicycle storage is proposed.






#### FIRST FLOOR - RETAIL SPACE





