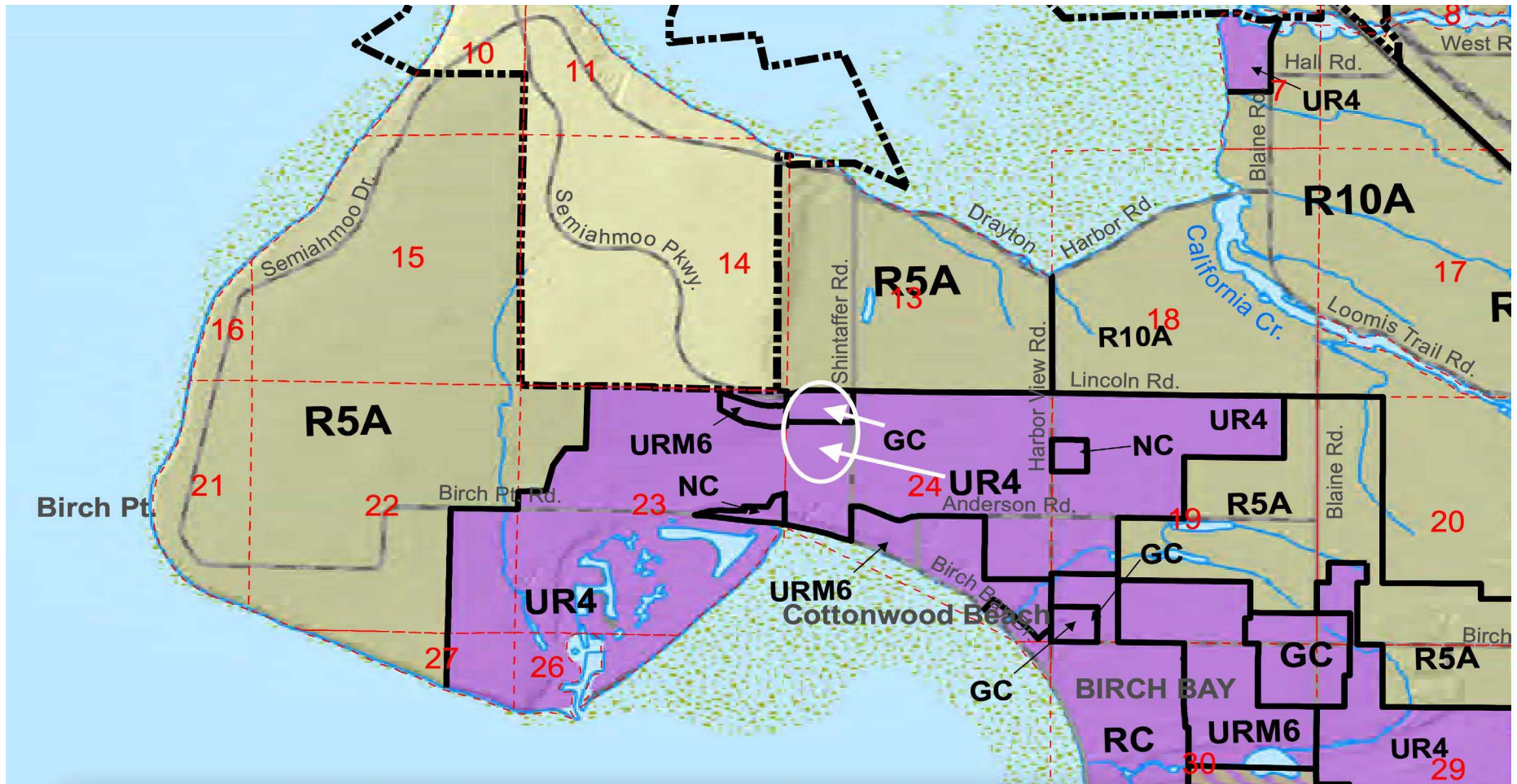

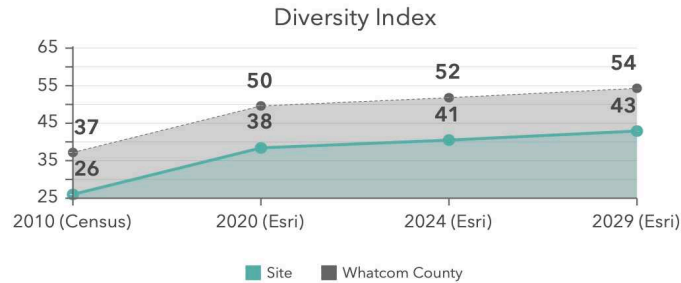

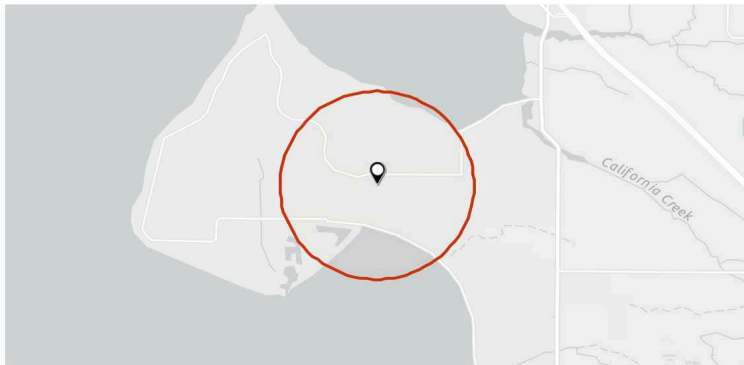
1 MILE RADIUS FROM SITE



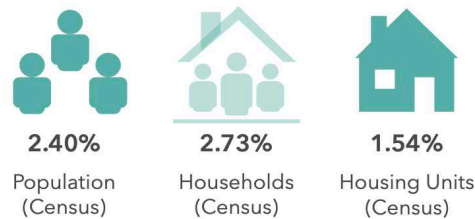

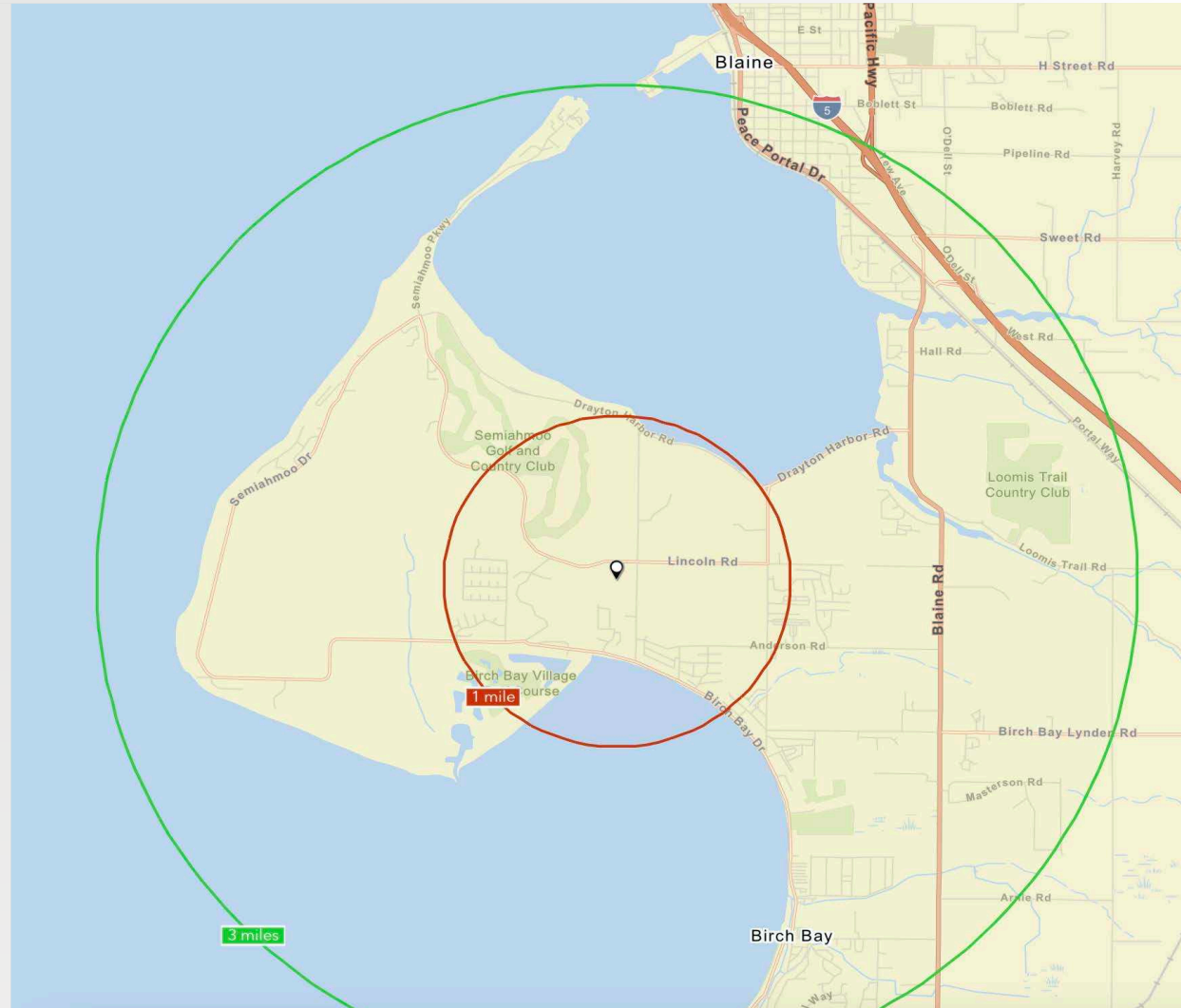


LOCATION OVERVIEW
