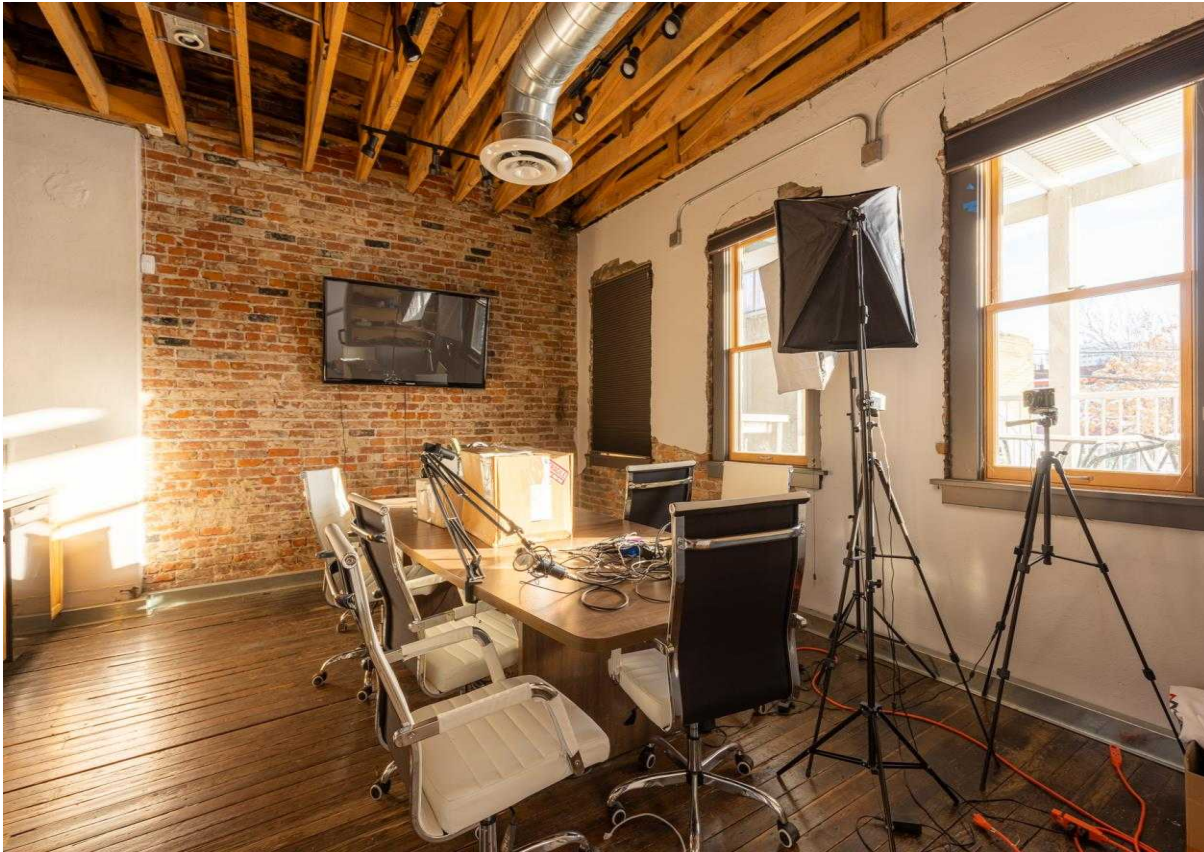

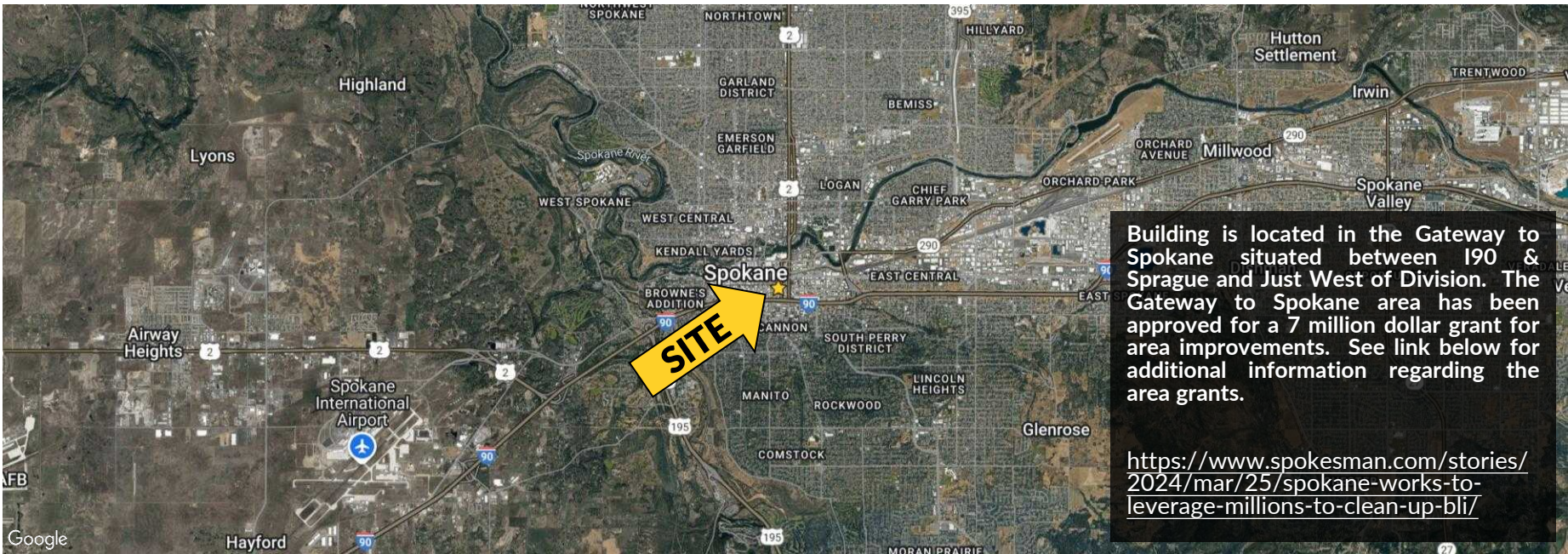
2ND LEVEL - OFFICE SPACE

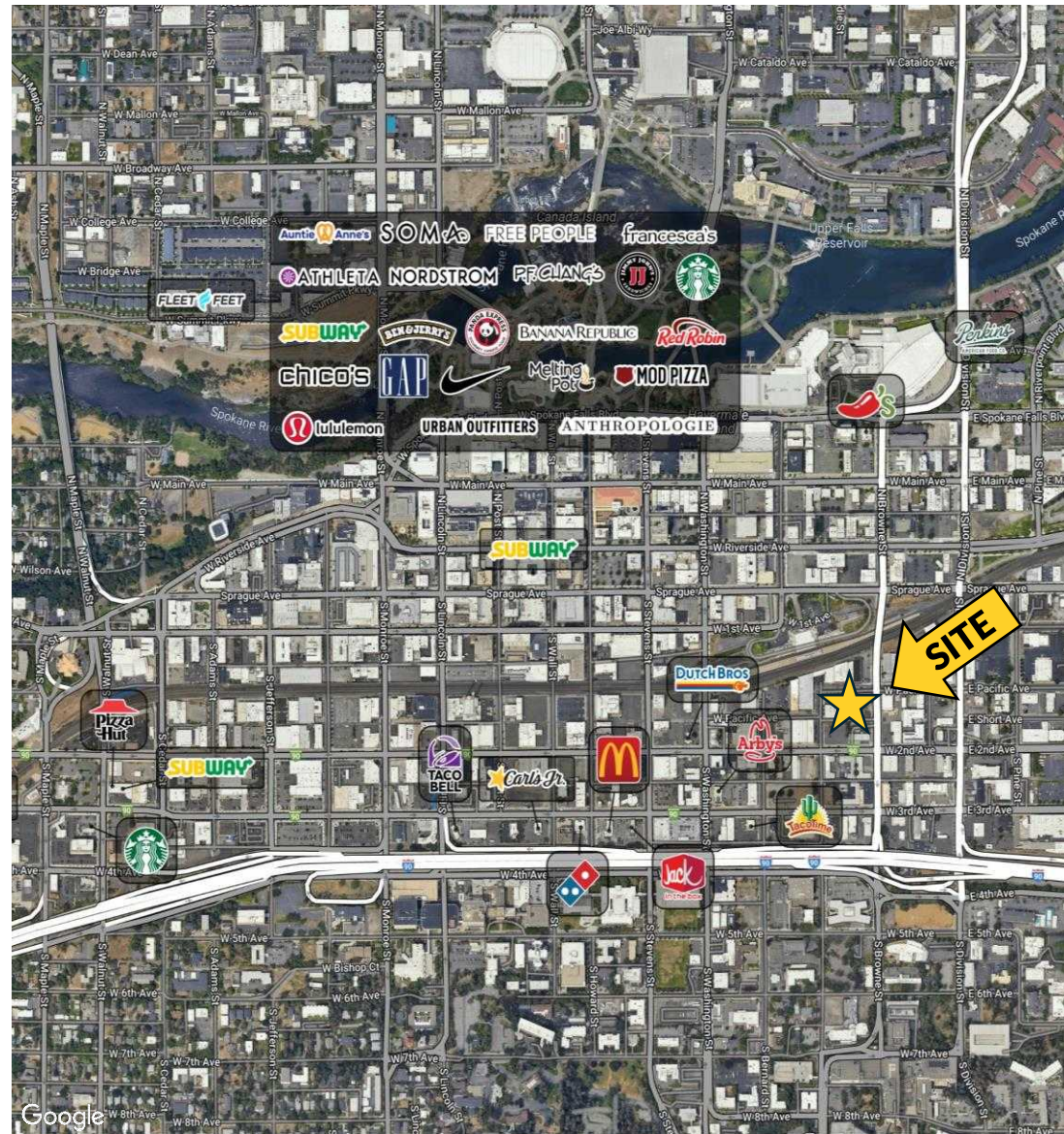
