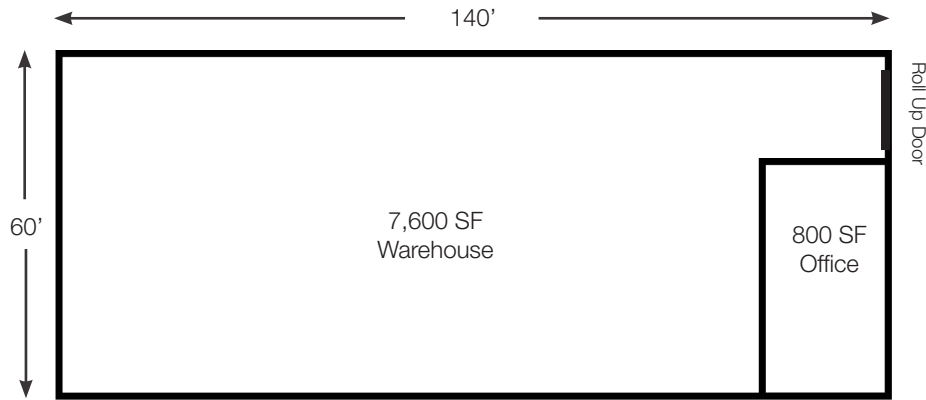

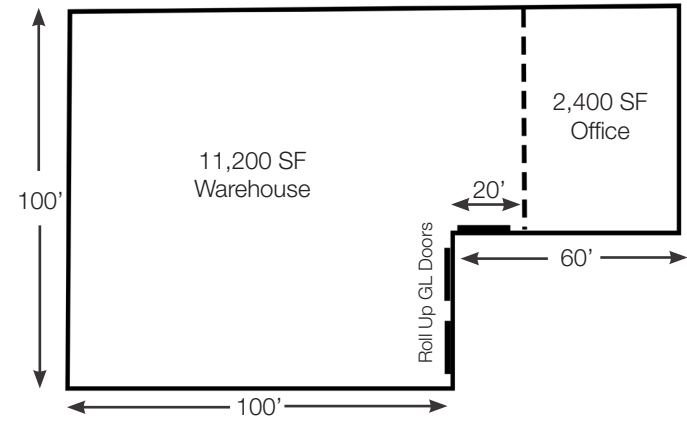


Floor Plans

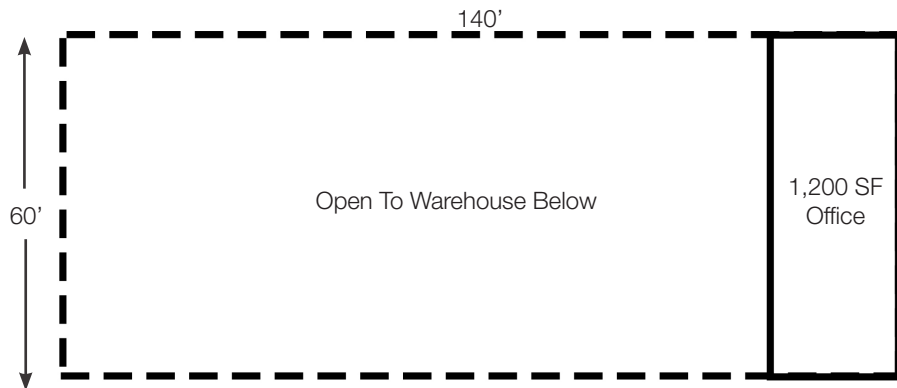
FIRST FLOOR



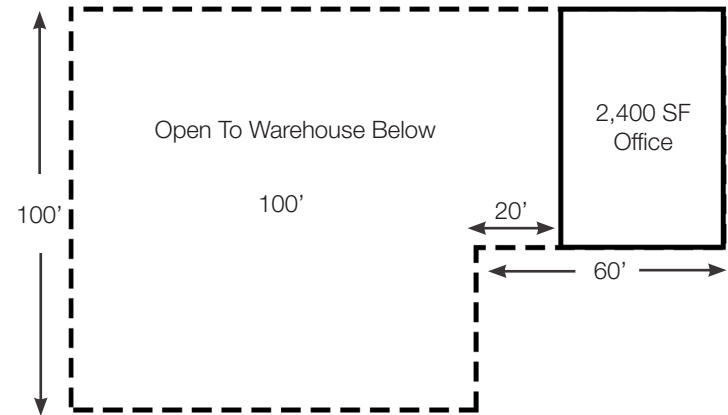
THIRD FLOOR
