LIVE-WORK-PLAY LOCATION

Belltown is one of Seattle's oldest neighborhoods and is a highly sought after live/work/play location, as evidenced by the population more than doubling since 2010. The area features desirable retail and multifamily demographics, with a high percentage of young well-compensated renters. It is the most dense residential neighborhood in the city and a tourism hotbed that includes countless trendy restaurants, iconic bars, coffee shops, art shops, boutique retailers, breweries, and nearby entertainment venues.

ACCESSIBLE LOCATION

First & Lenora has a perfect Transit Score of 100 and Walk Score of 98. The property is imminently accessible with easy access to freeways, light rail, the Seattle Streetcar, and metro bus services.
