Offered for sale is the stately Hermitage Court, a two-story Tacoma professional and medical office building located on South 72nd St near the I-5 on-ramp. Tacoma is the second largest city in the Puget Sound area. With a population of about 219,346, it's the third most populated city in the state. The South Sound region, with a population of about 1 million, is considered the economic and cultural center. Tacoma is also situated conveniently about 30 miles between Seattle and Olympia along I-5. Heritage Court's proximity to easy I-5 access is just one of the benefits.

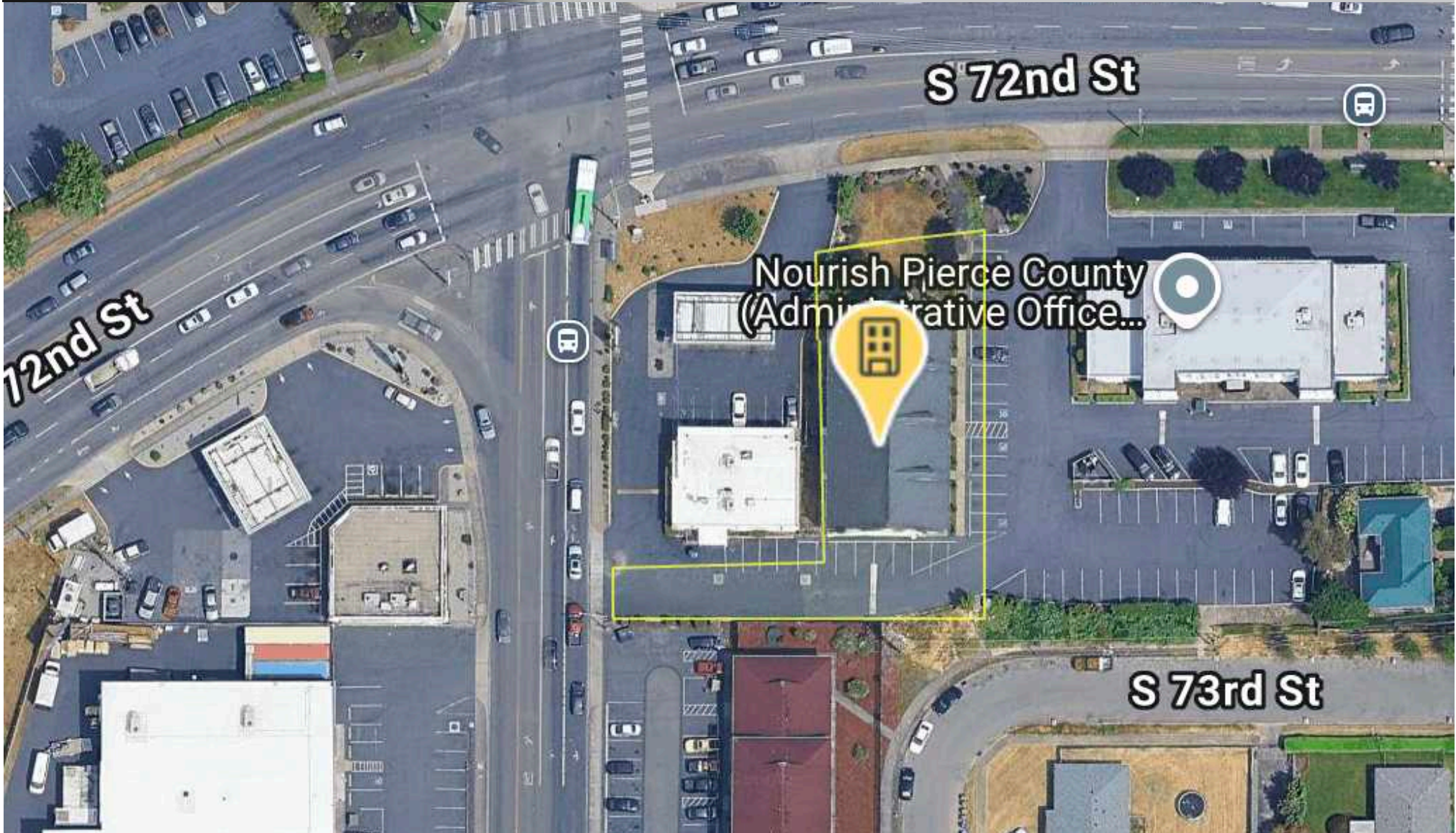

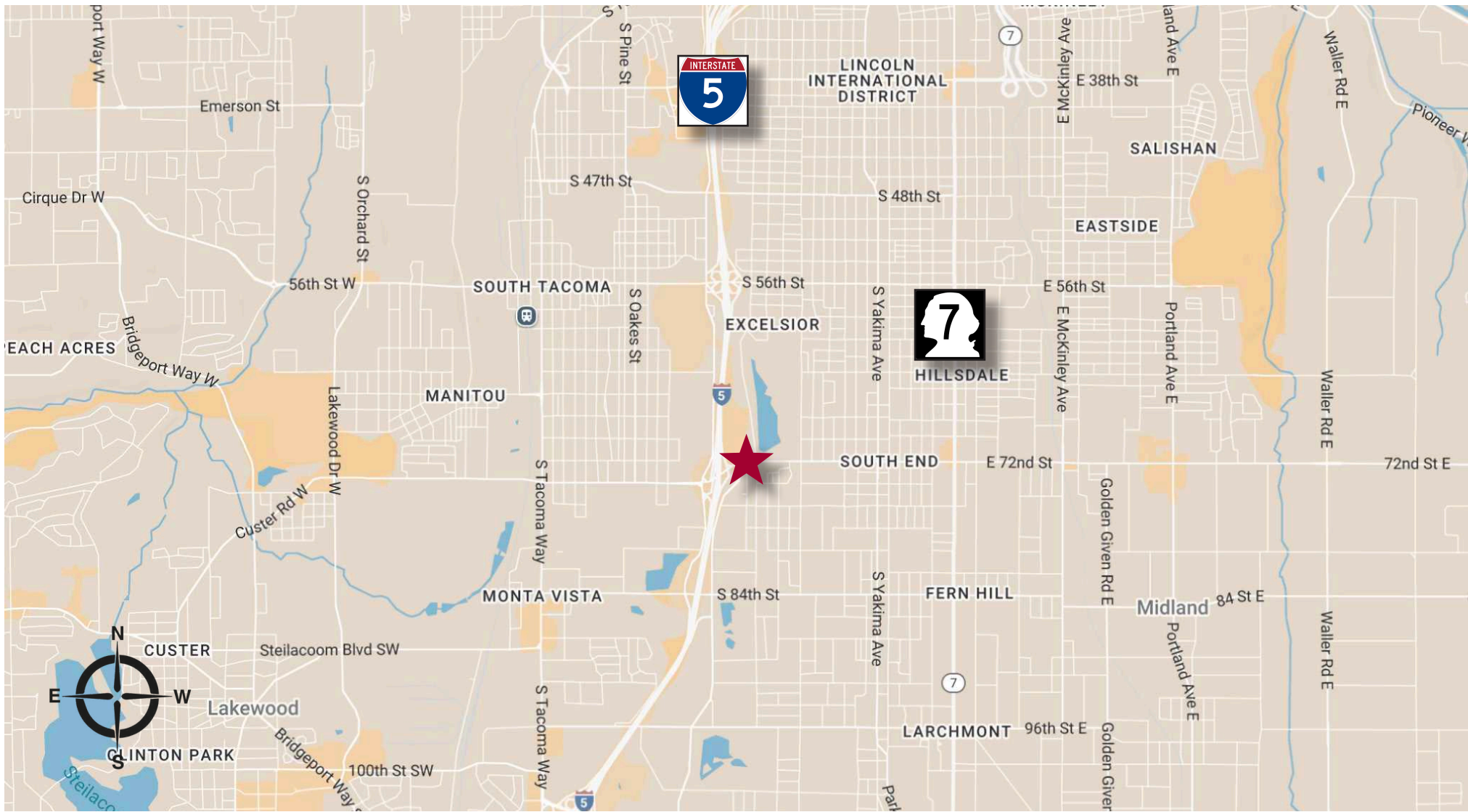
