

### Prosser Memorial Health

After two years of construction the \$112 million project to build a new Prosser Memorial Hospital is now open. The public hospital district bought the 33-acre site north of Interstate 82 at Exit 80 2017. It broke ground in 2022 after securing approval from the Washington Department of Health, the U.S. Department of Agriculture and the city of Prosser. The new Prosser Memorial will offer more of just about everything available at the hospital it is replacing: State-of-the-art surgical suites, more birthing options for maternity patients, family-friendly rooms, expanded ICU and cardiology capabilities and a larger emergency department. A separate office building will provide space for medical specialists. -Tri-City Herald


### Red Mountain AVA


