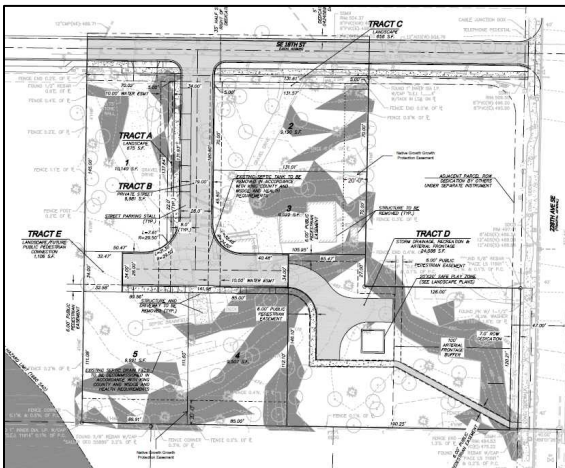

**NOTICE IS HERBY GIVEN** that on August 28, 2025, APPROVAL WITH CONDITIONS was granted by the Department of Community Development for the Donaldson Preliminary Short Subdivision. The proposal is to subdivide a 2.16-acre parcel within the R-4 zoning district into five (5) single-family residential lots. Access to Lot 1 will be directly off SE 18th ST and Lots 2-5 will get access from a new private road (TRACT B).
