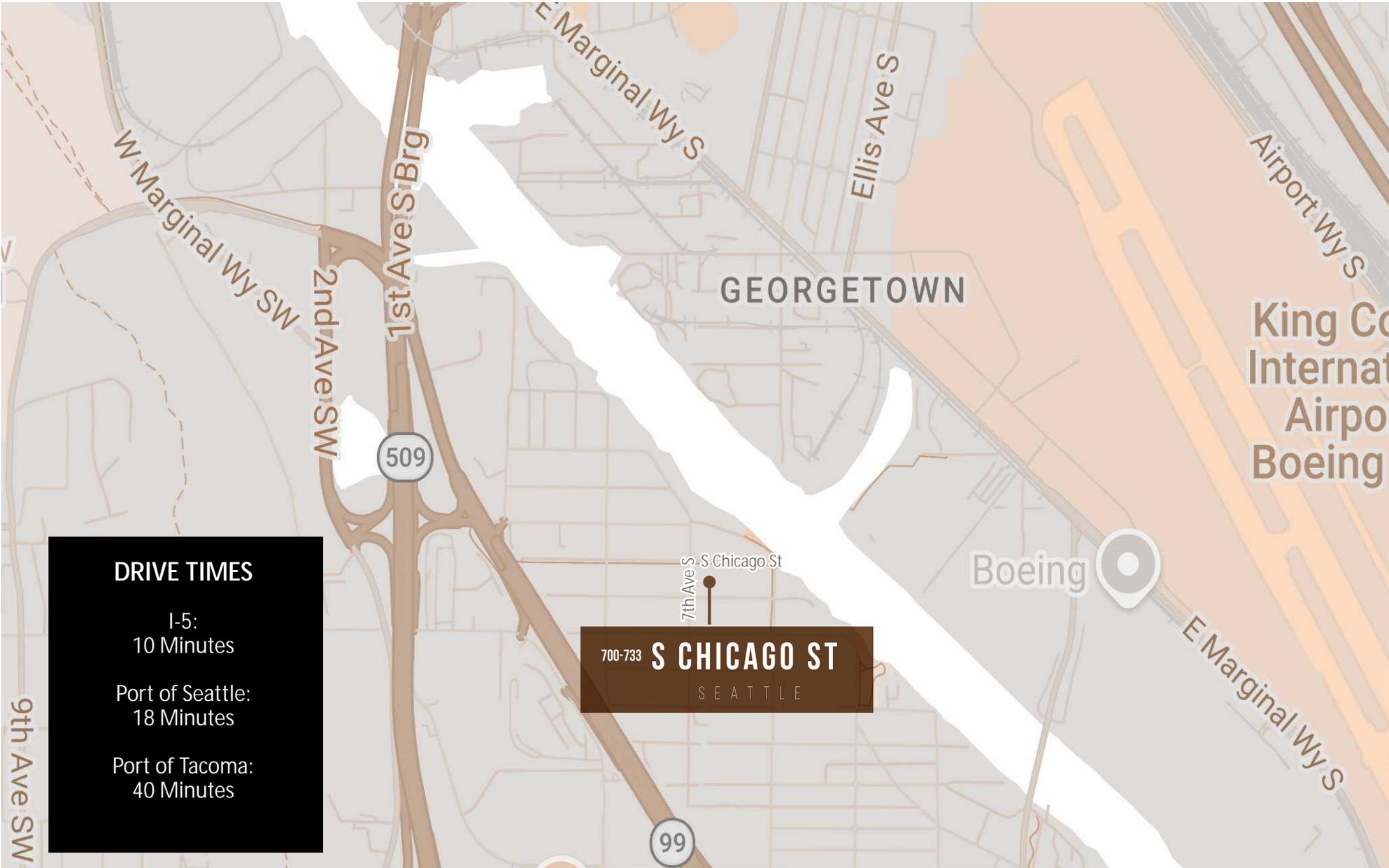


# PARCEL MAP
