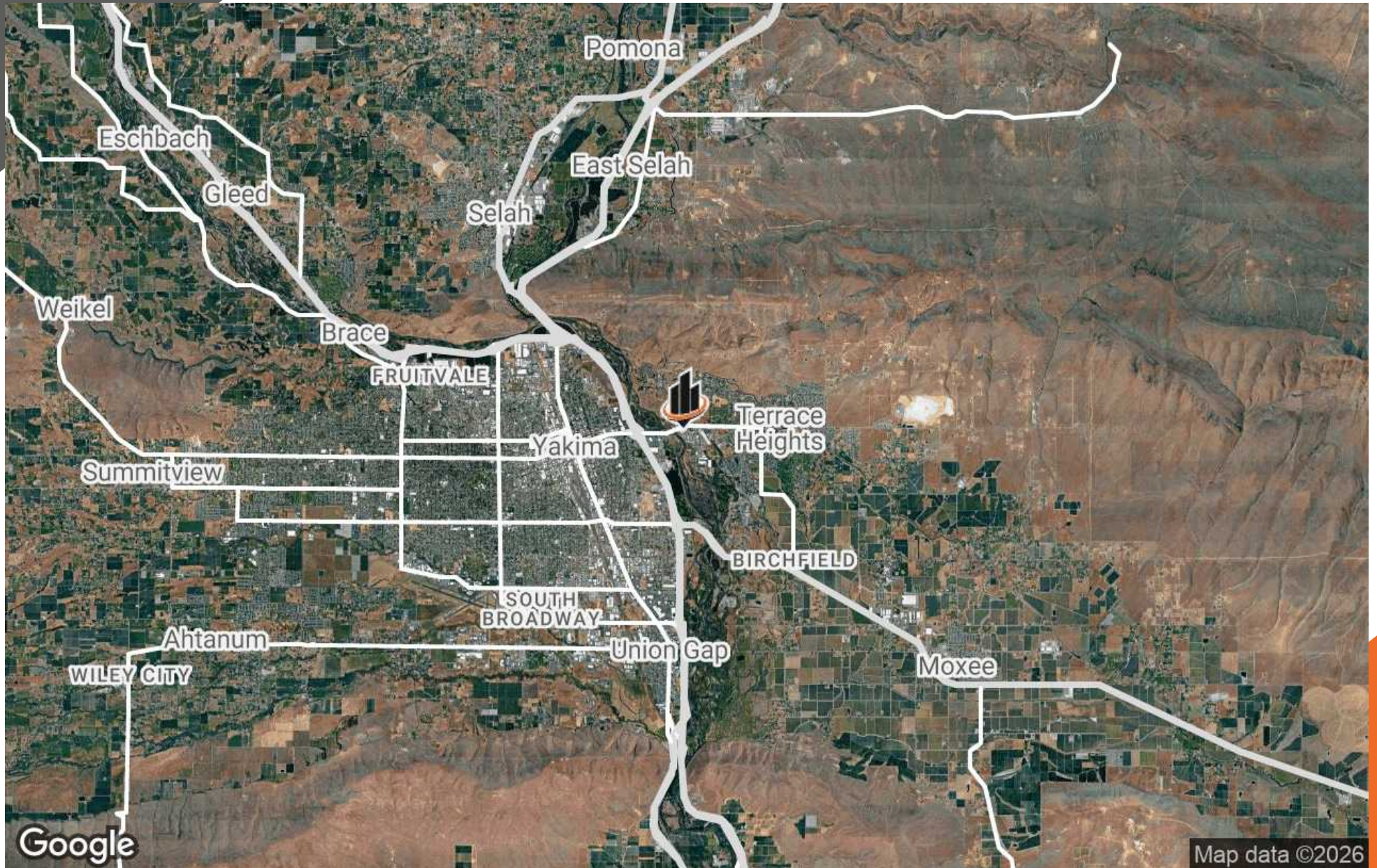

REGIONAL MAP

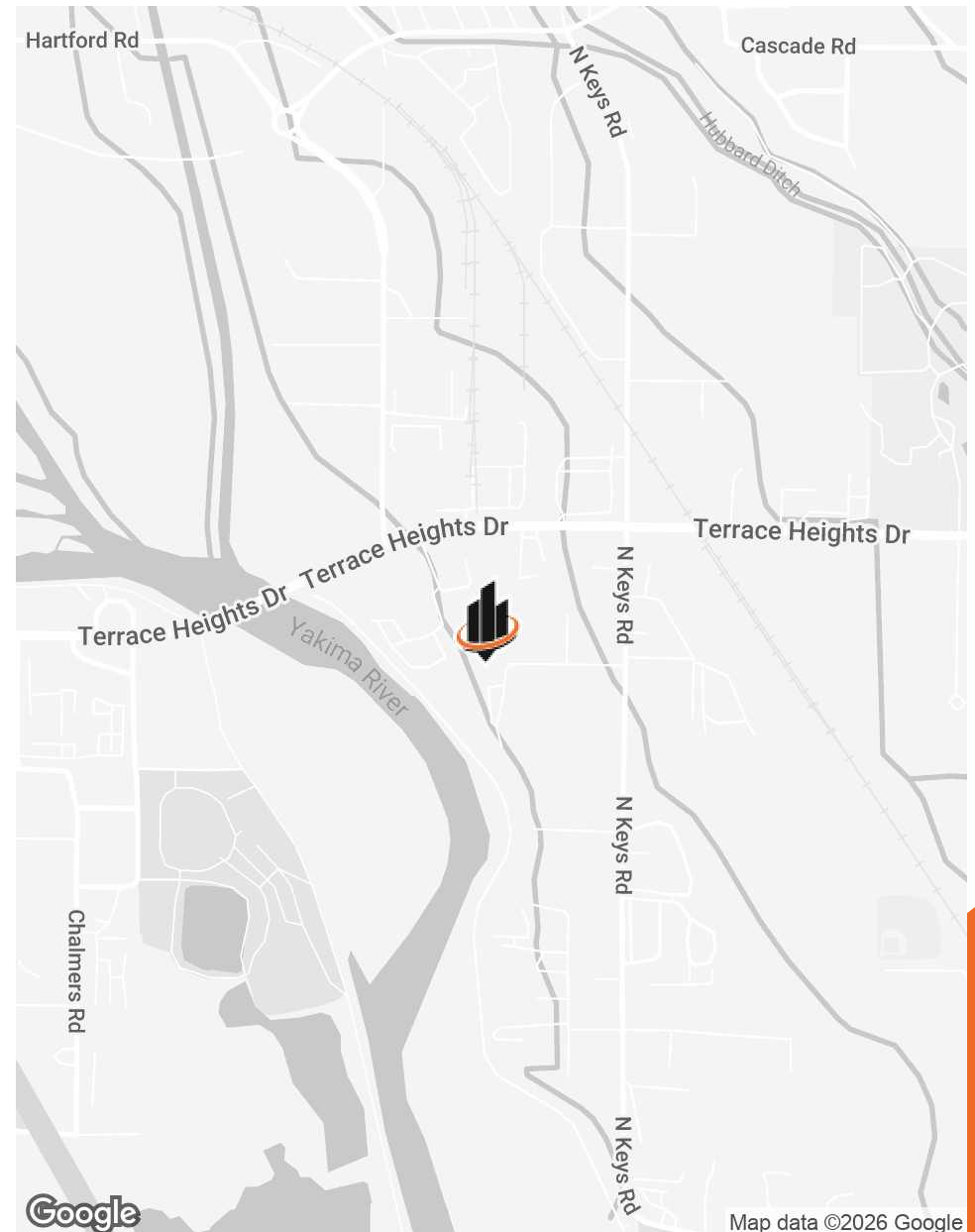
